



According to Bill McGee, USA Today, May 7th, "Reports from people on the plane indicate the evacuation may have been slowed by passengers grabbing their bags. Videos show passengers taking their carry-on bags with them as they exited the plane." The FAA said in a statement, "We will never know if more lives could have been saved if the bags were left behind" (source citation: "Were lives lost at the cost of carry-ons in Aeroflot plane crash that killed 41?"). This is unimaginable to me.

Visualize yourself being in this life-threatening situation. What would you do? Grab your bags or leave them behind? Jesus said, "... Take heed, and beware of covetousness: for a man's life consisteth not in the abundance of the things which he possesseth" (Luke 12:15). This verse is clear that those who would grab their bags, delaying the emergency exit and costing lives, are the very one's Jesus is convicting. While we may be glib at the thought of their seemingly greedy decision, Scripture teaches greed can have the same devastating effects in other situations in our own lives and the lives of those we influence.

Such, according to Paul, can be a "snare." "Iudicial lips, plunging men into 'destruction and perdition' that pierces them 'with many arrows'" (1 Timothy 6:9-10). What is Paul's insidious concern concerning such matters? "The dense thought" (1 Timothy 6:11).

An inordinate desire and pursuit of material things can damage not only ourselves, but also others we influence. Children, grandchildren, and others, whether we realize it or not, are observing what we value most, and what gets what our pronounced attention and affection. There is another who is observing too? Almighty God with His all-seeing eyes (Proverbs 15:3). The stakes are higher than whether one exits an airplane alive or not. It's all about how we leave this world and enter the next one. We must be keenly aware that this world can influence our judgment on the negative. We must be keenly aware that God can influence our judgment in the positive.
