# A RESOLUTION AMENDING THE 2024-2025 BUDGET FOR THE TOWN OF BOKCHITO, OKLAHOMA

**WHEREAS**, It is required by Bokchito Municipal Code and Oklahoma State Statute that the Chief Executive Officer has to prepare and submit a proposed budget to the Board of Trustees each fiscal year beginning July 1<sup>st</sup>; and

**WHEREAS**, The Board of Trustees have reviewed the proposed budget, held and public hearing and made revisions as it deemed desirable; and

WHEREAS, The Oklahoma Statutes provides that the Chief Executive Officer, when authorized by the appropriate governing body by resolution shall amend annual budgets as limited by law; and

**WHEREAS**, The Board of Trustees of the Town of Bokchito recognizes the necessity of amending the 2024-2025 fiscal year budget.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF BOKCHITO, OKLAHOMA:

**SECTION 1**. The Town of Bokchito budget beginning July 1, 2024, and ending June 30, 2025 is hereby amended as follows:

### GENERAL FUND REVENUE INCREASE

Fire Department – Tax Revenue from General Admin. - \$12,250.00 Fire Department – REAP Grant Funding - \$75,000.00

### GENERAL FUND APPROPRIATIONS DECREASE

Fire Department – Install Awning - \$9,250.00

Fire Department – Matching grant funds for equipment - \$3,000.00

Fire Department – Grant funds for equipment - \$75,000.00
