WHEREAS, The budget has been formally presented to the Bokchito Board of Trustees at least 30 days prior to the start of the fiscal year in compliance with Section 17-205; and

WHEREAS, The Bokchito Board of Trustees has conducted a Public Hearing at least 15 days prior to the start of the fiscal year, and published notice of the Public Hearing in compliance with Section 17-208 of the Act; and

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF BOKCHITO, OKLAHOMA:

SECTION 1. The Board of Trustees of the Town of Bokchito does hereby adopt the FY 2021-2022 Department Appropriation Budget on the 14th day of June 2021 with total resources available in the amount of \$1,379,148.70 and total departmental appropriations in the amount of \$1,264,068.12.
