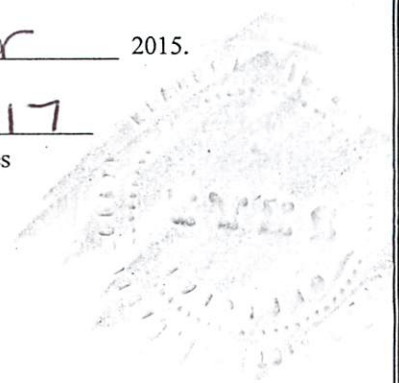

PROCLAMATION AND NOTICE OF ELECTION

Under and by virtue of Section 26, Article X of the Oklahoma Constitution and Title 70, Article XV, Oklahoma Statutes 2011, and other laws supplementary and amendatory thereto and a Resolution of the Board of Education of Independent School District Number 168 of Caddo County, Oklahoma, adopted on the 20th day of October, 2015, an election is hereby called to be held in said School District on the 12th day of January, 2016, for the purpose of submitting to the registered, qualified electors thereof the following proposition:

PROPOSITION

Shall Independent School District Number 168 of Caddo County, Oklahoma, incur an indebtedness by issuing its bonds in the sum of Six Million Four Hundred Thirty Five Thousand Dollars (\$6,435,000) to be issued in series to provide funds for the purpose of constructing, equipping, repairing and remodeling school buildings, acquiring school furniture, fixtures and equipment and acquiring and improving school sites, and levy and collect an annual tax, in addition to all other taxes, upon all the taxable property in such District sufficient to pay the interest on such bonds as it falls due and also to constitute a sinking fund for the payment of the principal thereof when due, said bonds to bear interest not to exceed the rate of ten (10%) percentum per annum, payable semi-annually and to become due serially within five (5) years from their date?

The ballots used at said election shall set out the proposition as above set forth and shall also contain the following words:

For the above Proposition

Against the above Proposition

The polls shall be opened at seven o'clock A.M. and remain open continuously until and be closed at seven o'clock P.M.

The number and location of the polling places and the names of the persons who shall conduct said election shall be designated by the County Election Board(s). Such officers shall also act as counters.

The specific projects for which at least eighty-five percent (85%) of the proceeds of the aforesaid Bonds shall be expended and the dollar amounts for each project shall be as follows:

SERIES I

Construct, furnish, equip, and/or acquire a new classroom building to include, but not be limited to: site improvements, utilities, demolition, and science lab equipment \$ 365,000.00

Construct, furnish, equip, and/or acquire improvements throughout the district to include, but not be limited to: electrical upgrades, flooring, paint, furniture, fixtures, equipment, playground improvements, and technology equipment \$ 605,000.00

Subtotal: Series I \$ 970,000.00

SERIES II

Construct, furnish, equip, and/or acquire a new classroom building to include, but not be limited to: concrete and portable classrooms \$ 485,000.00

Construct, furnish, equip, and/or acquire a new vo-ag building to include, but not be limited to: site work, utilities, concrete, paving and sidewalks \$ 430,000.00

Subtotal: Series II \$ 915,000.00

SERIES III

Construct, furnish, equip, and/or acquire a new classroom building to include, but not be limited to: paving, sidewalks, masonry, steel and steel erection, and millwork \$ 865,000.00

SERIES IV

Construct, furnish, equip, and/or acquire a new classroom building to include, but not be limited to: HVAC equipment and electrical \$ 820,000.00

SERIES V

Construct, furnish, equip, and/or acquire a new classroom building to include, but not be limited to: drywall, plumbing, joint sealants, doors, door frames, and door hardware \$ 775,000.00

SERIES VI

Construct, furnish, equip, and/or acquire a new classroom building to include, but not be limited to: aluminum entrances, glazing, general trades, flooring, ceramic tile, paint, toilet partitions, and specialties \$ 524,000.00

Construct, furnish, equip, and/or acquire a new vo-ag building to include, but not be limited to: millwork, joint sealants, doors, door frames, door hardware, aluminum entrances, glazing, overhead doors, coiling counter doors, general trades, and flooring \$ 211,000.00

CERTIFICATE OF EXCISE BOARD

State of Oklahoma, County of Caddo

We, do further certify that we have examined the statement of estimated needs for the current fiscal year ending June 30, 2015, as certified by the Board of Education of Hydro-Eakly Public Schools, District Number I-11 of said County and State, and its financial statement for the preceding year, and in so doing we have diligently performed the duties imposed upon this Excise Board by 68 O. S. 2001 Section 3007, by (1) ascertaining that the financial statements, as to the statistics therein contained, reflect the true fiscal condition at the close of the fiscal year, or caused the same to be corrected so to show; (2) struck from the estimate of needs so submitted any items not authorized by law and reduced to the sum authorized by law any items restricted by statute as to the amount lawfully expendable therefor; (3) supplemented such estimate, after appropriate action, by an estimate of needs prepared by this Excise Board to make provision for mandatory functions based upon statistics authoritatively submitted; (4) computed the total means available to each fund in the manner provided, applying the Governing Board's estimate of revenue to be derived from surplus tax of the immediately preceding year and from sources other than ad valorem tax, or reduced such estimate to not less than the lawfully authorized ratio of the several sums realized from such sources during the preceding fiscal year or to such lesser sum as may reasonably be anticipated under altered law or circumstance and using for such determination the basic collections of the preceding year and the ratios on which distribution or apportionment must be made during the ensuing or current year.

To the several and specific purposes of the estimated needs as certified, we have and do hereby appropriate the surplus balances of cash on hand of the prior year, estimates of income from sources other than ad valorem taxation within the limitation fixed by law, and the proceeds of ad valorem tax levy within the number of mills authorized, either by apportionment by the Legislature, allocation by the excise board or by legal election, all of which appropriations are made in so far as the available surpluses, revenues, and levies will permit, except in that we have also provided that, after deducting items consisting of cash and the revenue from all sources other than the 2015 tax and the proceeds of the 2015 tax levy are in excess of the residue of such appropriations, by a sum included for delinquent tax, computed at 10.0% of such residue. And provided further, if said School District has been ascertained to be a well defined State Aid District, the local budget, as approved and appropriated for, has been applied wholly to its operating accounts.

We further certify that the amount required to be raised from tax, excluding Homesteads, for General Revenue Fund purposes as approved, requires a total ad valorem tax levy of 35.000 Mills. Said levy is within the statutory limit, and if in excess, is within the constitutional limit and has been authorized by a vote of the people of said district, as shown by certificate of the School Board to-wit:

To this District, with valuations shown below, the Excise Board allocated 5.000 Mills, plus 15.000 Mills authorized by the Constitution, plus an emergency levy of 5.000 Mills; plus local support levy of 10.000 Mills; for a total levy for the General Fund of 35.000 Mills.

We further certify that the amount required to be raised for building fund purposes as approved requires a tax levy of 5.000 Mills, and said levy has been certified as authorized by a vote of the people at an election held for that purpose. We further certify that Assessed Values used in computing Mill-vote levies have been applied as certified by the County Assessor.

We further certify that we have examined the within statements of account and estimated needs or requirements of the Governing Board of Hydro-Eakly Public Schools, School District No. I-11 of said County and State, in relation to the Sinking Fund or Funds thereof, and after finding the same correct or having caused the same to be corrected pursuant to 68 O. S. 2001 Section 3009, have approved the requirements therefor to fulfill the conditions of Section 26 and 28 of Article 10, Oklahoma Constitution, and have made and certified a tax levy therefor to the extent of the excess of said total requirements over the total of items 2, 3, 6, and 12 of Exhibit "Y" and any other legal deduction, including a reserve of 10% for delinquent taxes.
