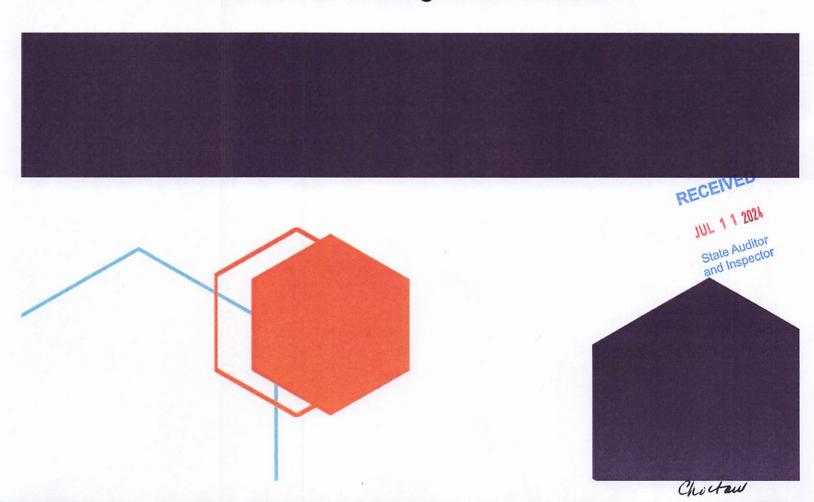

#### Memorandum Regarding the Adopted FY2024-2025 Budget

The City of Hugo is pleased to present the proposed budget for the fiscal year ending June 30, 2025. The budget reflects the following:

- Tax receipts are expected to show a slight increase, reflecting continuing price increases due to inflation.
- General fund expenditures are budgeted slightly higher than last year, but below the current year's actual due to lower grant revenues.
- Salaries and benefits include a 2% cost of living adjustment.
- Street improvements are expected to continue with \$250,000 budgeted in the Street and Alley Fund.
- The construction of a new water treatment plant that that began in FY2022 was nearly completed in the prior fiscal year, so capital expenditures are lower for the Hugo Municipal Authority
