NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF THE CITY OF DRUMRIGHT BOARD that:





WHEREAS, the Drumright Utility Trust did not budget this amount in 2015-16 operating budget as well;





WHEREAS, the City of Drumright General Fund must increase the budget to accommodate Fire Department expense for the purchase of stabilization jacks; and


