BUDGET MESSAGE

The upcoming FY 2024-2025 annual budget for the Town of Drummond includes some significant components that reflect the Town's continuing efforts to provide quality services.

The budget outlines the expenditures in the form Personal Services, Maintenance& Operations, Capital Outlay and Fund Transfers, as follows:

- 1. Personal Services: Includes expenses for salaries and taxes.
- 2. Maintenance and Operations: Includes expenses for utility services, postages, vehicle expenses, advertising dues, office supplies, chemicals, equipment parts, supplies, employee training, grounds upkeep, insurance, street lighting, telephone services and testing fees.
- 3. Capital Outlay: Includes expenses for equipment, machinery, and vehicles.
- 4. Fund Transfers: Are the transfer of funds from one another fund within the budget.
- 5. Capital Improvement Fee: A fee of which is used to pay for infrastructure needs, As of now the Town of Drummond is using this to help pay for our sewer lagoon rehabilitation.

Drummond General Fund: \$131,801.74

Drummond Public Works Authority: \$191,026.98

Street and Alley Funds: \$8,058.12 Fire Department Fund: \$35,756.19 Meter Deposit Fund: \$12,604.90
