
At said hearing the Trustees considered and adopted the Oklahoma Municipal Budget Act, 11 O.S. Sections 17-201 to 17-218. The Trustees specifically adopted the provisions of Budgeting by Purpose. The Budget as presented by the Mayor has been approved by a majority, affirmative vote of Trustees Phillips, Burch and Schaffer. The Mayor is further authorized by a majority affirmative vote of Trustees Phillips, Burch and Schaffer, to transfer any unexpected and unincumbered appropriations from one Purpose to another.



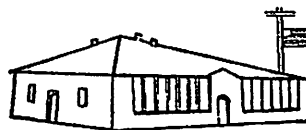
