Town of Foster, Oklahoma Budget Message For the Year Ended June 30, 2021

On the following pages is the budget document for the Town of Foster, Oklahoma for the fiscal year 2020-2021 as required by Oklahoma Statutes (O.S. Title 11, Secs. 17-201 through 17-216).

This document adequately provides the programs, services and capital expenditures determined to be necessary and beneficial by the Town Board, and it provides for certain amounts of fund balances to be retained which would be available for cases of public emergency or would be carried forward to the next fiscal year, if not used.

The document presented herein contains the following highlights:

- Plans to complete construction a new Town Hall/Storm Shelter for \$125,000 and \$5,000 for furniture and fixtures. Also, estimated cost to operate Town Hall.
- Plans for construction of Town Hall parking lot for \$75,000
- Plans to extend the water line to the Town Hall/Storm Shelter for \$5,000
- Road improvements of \$90,000
- Town signs for \$20,000
- Plans to assist with road bore and line extension to serve Town Hall and the north side of N County Road 3105 for \$60,000

The document is prepared in a format to show the following information about the revenues, expenditures, and fund balances of each of the Town's operating funds:

- Actual Amounts for 2018-2019
- Budgeted Amounts for 2019-2020
- Actual Amounts through 04/30/2020
- Projected Amounts through 06/30/2020
- Proposed Budget Amounts for 2020-2021

This format is designed so that members of the Board, staff and general public can readily see the past, present and expected future activities within each fund.

Under the budget process, a consultant prepares the budget document with input from the Mayor. This proposed budget is published with notification of a public hearing. The public hearing enables the Board of Trustees to receive additional information and feedback from the Town's citizens. After such hearing, further changes may be made to the budget before its final adoption by the Board prior to the beginning of the 2020-2021 fiscal year.

It is the intent and hope of the Board that this process will allow for diligent, timely and responsible preparation of a fiscal budget document, which can best serve the needs of the Town of Foster and its citizens.
