RE 2022/2023 Annual Budget

The FY 2023 Annual Budget for the Town of East Duke is presented, as attached, for approval by the Council in accordance with the Oklahoma Municipal Budget Act.

The budget includes the following highlights for fiscal year 2022 / 2023:

- Tax revenues have been budgeted at 90% of current year projections. This equates to a reduction in budgeted Tax revenues of <~\$9,500> from this years projected revenue collections.
- Capital Outlay includes Building work, Bunker Gear & a Brush Truck for the Fire Department for approximately \$230,000 & Street resurfacing for \$135,000.
- The recent pay increases approved by the board are included in this budget.
- No utility rate increases are included in the budget at this time.
- **This budget projects an overall loss of <\$89,062> for fiscal year 2023.**
- *Please keep in mind that Oklahoma municipalities have to rely upon tax and utility revenues to provide services to citizens. These revenues must be able to fund current operations and capital outlay, as well as provide reserves for future capital projects.*

The legal level of control for the Town's 2022 / 2023 budget is established at the Department level. Additional detail is provided for analysis purposes only.

**A RESOLUTION APPROVING THE TOWN OF EAST DUKE, OKLAHOMA BUDGET FOR THE FISCAL YEAR 2022 - 2023 AND ESTABLISHING BUDGET AMENDMENT AUTHORITY**

**WHEREAS**, The Town of East Duke has adopted the provisions of the Oklahoma Municipal Budget Act (the Act) in 11 O.S. Sections 17-201 through 17-216; and

**WHEREAS**, The Chief Executive Officer has prepared a budget for the fiscal year ending June 30, 2022 (FY 2020 - 2021) consistent with the Act; and

**WHEREAS**, The Act in section 17-215 provides for the chief executive office of the Town, or designee, as authorized by the governing body, to transfer any unexpended and unencumbered appropriation from one department to another within the same fund; and

**WHEREAS**, The budget has been formally presented to the Town of East Duke governing body at least 30 days prior to the start of the fiscal year in compliance with Section 17-205; and

**WHEREAS**, The Town of East Duke governing body has conducted a Public Hearing at least 15 days prior to the start of the fiscal year, and published notice of the Public Hearing in compliance with Section 17-208 of the Act; and

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE  
TOWN OF EAST DUKE, OKLAHOMA:**

**SECTION 1.** The Town Council of the Town of East Duke does hereby adopt the FY 2022 - 2023 Budget on the 15th day of June 2022 with total resources available in the amount of approximately \$2,756,291 and total fund/departmental appropriations in the amount of \$1,631,918. Legal appropriations (spending/encumbering limits) are hereby established as follows:



**SECTION 3.** All supplemental appropriations or decrease in the total appropriation of a fund shall be adopted at a meeting of the Town Council and filed with the State Auditor and Inspector.


