

TO THE MEMBERS OF THE OKLAHOMA HORSE RACING COMMISSION

We performed an audit in accordance with the OHRC Gaming Contract and Title 3A of the Oklahoma Statutes for Gaming. The information presented in this report is derived from gaming data obtained from the gaming vendors and licensees located at Will Rogers Downs and Remington Park for the month of July 2017.

Because our procedures do not constitute an audit conducted in accordance with generally accepted auditing standards, we do not express such an opinion on the information. This report relates only to this information and does not extend to any financial statements of the racetracks or racinos.

In planning and performing these procedures, we considered the internal control structure of the gaming departments; however, our procedures were substantially less in scope than the procedures we would have applied if we had been engaged to express an opinion on the internal controls. Accordingly, we do not express an opinion on their internal control structure.

Title 3A Section 262 B. of the Oklahoma State Statutes, effective July 1, 2017, allows twenty-four hour gaming at gaming facilities. Remington Park is the only gaming facility that has chosen to implement the change. Originally, Remington Park's slot accounting system included gaming revenue from the six-hour time period, midnight to 6:00 AM on July 1, 2017, in the June 30, 2017 Adjusted Gross Revenue. Remington Park has since determined this revenue should be included in the Adjusted Gross Revenue for July 1, 2017 to insure compliance with the new statutes. Therefore, they have adjusted that revenue from June 30, 2017 to July 1, 2017. The corrected June 30, 2017 Adjusted Gross Revenue now only includes gaming revenue through midnight on June 30, 2017. We have reviewed Remington Park's adjustments to the Adjusted Gross Revenue and believe they are reasonable.

Title 3A Section 204.1D. of the Oklahoma Statutes, effective July 1, 2017, allows for a new funding mechanism for the Oklahoma Horse Racing Commission to receive one half of one percent of the Adjusted Gross Gaming Revenue. The Casino and the Horsemen's funds share equally in the additional funding of the OHRC. We added a line item in the report as of the July 1, 2017 to track OHRC's dollars.










