June 8, 2023	NOTICE OF THE DATE, TIME, AND PLACE OF THE BUDGET HEARING AND THE PROPOSED BUDGET SUMMARY SHALL BE PUBLISHED IN THE LINCOLN COUNTY NEWSPAPER AND ON THE TOWN WEBSITE NOT LESS THAN FIVE (5) DAYS BEFORE THE DATE OF THE HEARING.
June 15, 2023	GOVERING BODY MUST HOLD A PUBLIC HEARING ON THE PROPOSAL NO LATER THAN FIFTEEN (15) DAYS PRIOR TO THE FISCAL YEAR BEGINNING JULY 1, 2023.
June 15, 2023	GOVERNING BODY MUST ADOPT THE BUDGET BY RESOLUTION AT LEAST SEVEN (7) DAYS PRIOR TO THE BEGINNING OF THE FISCAL YEAR.
June 23, 2023	ADOPTED BUDGET MUST BE FILED WITH THE STATE AUDITOR AND INSPECTOR AND THE MUNICIPAL CLERK ON OR BEFORE THE FIRST DAY OF THE FISCAL YEAR.

WITHIN FIFTEEN (15) DAYS AFTER FILING WITH THE STATE AUDITOR AND INSPECTOR, ANY TAXPAYER MAY PROTEST ALLEGED IRREGULARITIES.

Section 17-208 of that Act;




