A RESOLUTION OF THE GOVERNING BODY OF THE TOWN OF SPARKS,

EXPRESING THE INTENT OF THE TOWN OF SPARKS TO COMPLY WITH AND OPERATE IN ACCORDANCE WITH THE MUNICIPLE BUDGET ACT: AND TO BEGIN APPLICATION OF THIS ACT EFFECTIVE WITH THE BUDGET FOR THE FISCAL YEAR 2023/2024.

WHEREAS, The Municipal Budget Act (Section 17-201 through 17-216 of the Oklahoma Statues) provides an alternative budget procedure for municipal governments: AND

WHEREAS, this act establishes first practices requires greater financial disclosure for the public and investors, and allows municipalities to improve, and implement generally accepted standards of financial management: AND

WHEREAS, The Town of Sparks may elect to come under the Municipal Budget Act by adoption of a resolution:

AND THEREFORE, BE IT RESOLVED BY THE TOWN BOARD OF TRUSTEES OF THE TOWN OF SPARKS THAT:

- 1) The Town of Sparks elects to comply with and operate in accordance with the terms and provisions of the Municipal Budget Act (Sections 17-201 through 127-2156 of Title 11 of the Oklahoma Statues: AND
- 2) The provisions of the Municipal Budget Act will be effective for the Town of Sparks beginning with the budget for the fiscal year of 2023 which begins July 1, 2022 and will, as provided in the Act, take precedence over and supersede any other state laws applicable to municipal budgeting: AND
- 3) The chief Executive Officer, as defined in the Act, is hereby authorized to take such action as are necessary to meet the requirements of the Act.
