We compiled the information presented in this report from the statistical data obtained from the gaming vendors and licensees located at Will Rogers Downs and Remington Park for the month of May 2011 as (Amended).

We were not engaged to perform an audit in accordance with generally accepted auditing standards, the objective of which would be the expression of an opinion on specified elements or accounts. Accordingly, we do not express such an opinion. This report relates only to the procedures specified above and does not extend to any financial statements of the racetracks or racinos taken as a whole.

In planning and performing these procedures, we considered the internal control structure of the gaming departments; however, our procedures were substantially less in scope than the procedures we would have applied if we had been engaged to express an opinion on the internal controls. Accordingly, we do not express an opinion on their internal control structure.

SUBSEQUENT EVENT NOTE TO THE AUDIT REPORT

THE OKLAHOMA STATE AUDITOR AND INSPECTOR OFFICE AMENDED RECEIPTS DUE TO THE NOTE BELOW:

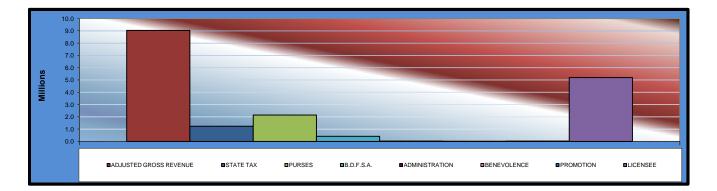
Oklahoma State Law in Title 3A, SS 262 E. and F. provides that total receipts less monetary payouts will equal adjusted gross receipts. Adjusted gross receipts are the basis on which distributions are made to the state as well as other groups such as horse owners, trainers, and breeders. We find no statutory provisions for reducing total receipts.

Global Gaming Solutions LLC, the owner of Remington Park is currently excluding promotion expense items such as Free Play Credits from total receipts. This results in an understatement of adjusted gross receipts. As state law has no provision for any reduction in total receipts, we believe Global Gaming Solutions LLC is underpaying the state and the other affected parties. Such an underpayment to the state will have an adverse effect on the Higher Education and Common Education systems of the state, who receive the benefit. We believe that any promotion expenses or items that Global Gaming Solutions LLC desires to utilize is an expense of Global Gaming Solutions LLC and that the state and other parties interests should not be affected by such. Such a use of the state's share of adjusted gross receipts would appear to be a violation of Article X Section 15 of the state's constitution, which would prohibit the giving away of any monies properly belonging to the state.

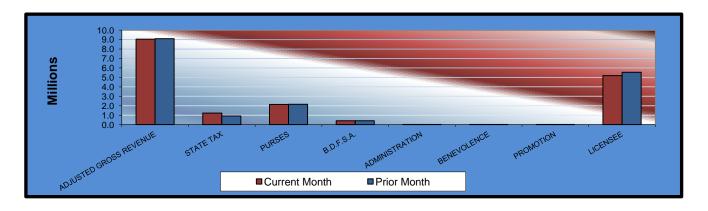
We have found no other authorization for such a reduction of total receipts. Therefore we will refer this matter to the Attorney General for further resolution.

As the law does allow the Oklahoma Horse Racing Commission to issue rules to regulate and enforce these provisions of the law, we also recommend that the Oklahoma Horse Racing Commission review this matter and issue appropriate rules where necessary to prevent this and any other attempts to reduce the total receipts calculation or any other unauthorized attempts to reduce the adjusted gross receipts.

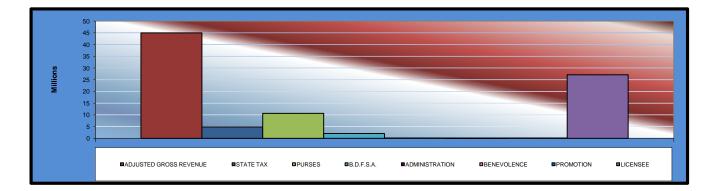
