RESOLUTION TOWN OF WAYNE NO. 24-3

A RESOLUTION OF THE GOVERNING BODY OF THE TOWN OF WAYNE, OKLAHOMA, ADOPTING THE FISCAL YEAR 2024-2025 ANNUAL BUDGET FOR THE TOWN OF WAYNE, OKLAHOMA, AND SPECIAL REVENUE FUNDS IN ACCORDANCE WITH THE PROVISIONS OF THE MUNICIPAL BUDGET ACT.

WHEREAS, the provisions of the Municipal Budget Act (Section 17-201 through 17-216 of Title 11 of the Oklahoma Statues) have been previously adopted by the Town of Wayne, Oklahoma; and

WHEREAS, Section 17-209A requires the annual budget to be adopted by the governing body of the Town of Wayne, Oklahoma by resolution no later than seven (7) days prior to the beginning of the fiscal year.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF WAYNE, OKLAHOMA:

<u>Section 1.</u> The accompanying annual budget document sets forth the estimated revenue and appropriations for each fund as approved by the Town of Wayne Board of Trustees.

<u>Section 2.</u> The accompanying budget document complies with the requirements of the Act by including:

- a. The budget message.
- b. The budget summary.
- c. The fund budget summaries.
- d. The departmental appropriations.

<u>Section 3.</u> In accordance with Section 17-215B, the Town of Wayne Board of Trustees has determined that expenditures and encumbrances may not be authorized that exceed the legal level of control by account category (as defined in Section 17-213) of any department of any fund.

<u>Section 4.</u> All budget amendments, including supplemental, decrease or transfer appropriations, to the legal level of control as defined above will require governing body approval.


