

TOWN OF DIBBLE ORDINANCE NO. 2017-111

AN ORDINANCE OF THE TOWN OF DIBBLE, OKLAHOMA, AMENDING PARAGRAPH C OF SECTION 16-23 TO CHAPTER 16 OF THE DIBBLE CODE OF ORDINANCES PROVIDING FOR SEWER TAP FEES AND AMENDING SECTION 16-24 TO CHAPTER 16 OF THE DIBBLE CODE OF ORDINANCES PROVIDING FOR SEWER PENALTIES.

BE IT ORDAINED BY THE MAYOR AND BOARD OF TRUSTEES OF THE TOWN OF DIBBLE, OKLAHOMA:

**SECTION 1.** That Paragraph C of Section 16-23 of Chapter 16 of the Dibble Code of Ordinances is hereby amended and shall, from and after the effective date of this Ordinance, read as follows:

**Section 16-23. Sewer Rates and Fees.**

C. The deposit for all new sewer and water accounts shall be two hundred fifty dollars (\$250.00). Upon termination of service and payment of all sewer charges owed to the Town of Dibble, the deposit shall be returned to the customer within 30 days after termination of service.

**SECTION 2.** That Section 16-24 of Chapter 16 of the Dibble Code of Ordinance is hereby amended and shall, from and after the effective date of this Ordinance, read as follows:

**Section 16-24. Penalty For Failure to Pay Sewer Bills.**

A late fee equal to 10% of the amount of the sewer bill shall be charged on all sewer service bills that are not paid on or before the due date.

**SECTION 3. Severability.** If any section, subsection, sentence, clause, phrase or portion of this ordinance is, for any reason, held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision, and such holding shall not affect the remaining portions of this ordinance.

**SECTION 4. Emergency.** It being necessary for the health, safety and welfare of the residents of the Town of Dibble, Oklahoma, that this ordinance, be adopted and implemented immediately, an emergency is hereby declared to exist, by reason whereof the provisions of this Ordinance shall become effective immediately upon the passage and approval of this Ordinance, all as required by Law.

TOWN OF DIBBLE ORDINANCE NO. 2017-110

AN ORDINANCE OF THE TOWN OF DIBBLE, OKLAHOMA, MAKING ADJUSTMENTS TO THE BUDGET FOR FISCAL YEAR 2016-2017 FOR THE TOWN OF DIBBLE, OKLAHOMA.

BE IT ORDAINED BY THE MAYOR AND BOARD OF TRUSTEES OF THE TOWN OF DIBBLE, OKLAHOMA:

**SECTION 1.** That there shall be an additional amount of revenue in the amount of \$17,000.00 appropriated to the Fire Department Capital Outlay in order to accommodate the siren project.

**SECTION 2.** That there shall be an additional amount of revenue in the amount of \$34,100.00 appropriated to Contribution Expense in order to accommodate bills paid by the General Fund for the DPWA that will not be paid back to the General Fund.

**SECTION 3. Severability.** If any section, subsection, sentence, clause, phrase or portion of this ordinance is, for any reason, held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision, and such holding shall not affect the remaining portions of this ordinance.

**SECTION 4. Emergency.** It being necessary for the health, safety and welfare of the residents of the Town of Dibble, Oklahoma, that this ordinance, be adopted and implemented immediately, an emergency is hereby declared to exist, by reason whereof the provisions of this Ordinance shall become effective immediately upon the passage and approval of this Ordinance, all as required by Law.
