WHEREAS, this Act establishes fiscal practices, requires greater financial disclosure for the public and investors, and allows municipalities to improve and implement generally accepted standards of financial management; and

WHEREAS, the City (or Town) of WAINWRIGHT may elect to come under the Municipal Budget Act by adoption of a resolution.

AND, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL (or TOWN BOARD OF TRUSTEES) OF THE CITY (or TOWN) OF WAINWRIGHT THAT:

- The City (or Town) of WAINWRIGHT elects to comply with and operate 1. in accordance with the terms and provisions of the Municipal Budget Act (Sections 17-201 through 17-216 of Title 11 of the Oklahoma Statutes; and
- The provisions of the Municipal Budget Act will be effective for the City 2. (or Town) of WAINWRIGHT beginning with the budget for fiscal year 2016-2017 which begins on July 1, 2016 will, as provided in the Act, take precedence over and supersede any other state laws applicable to municipal budgeting; and
- The Chief Executive Officer, as defined in the Act, is hereby authorized to 3. take such actions as are necessary to meet the requirements of the Act.
