

**RESOLUTION NO. 2015-06-01**

**A RESOLUTION OF THE CITY OF NOWATA, OKLAHOMA, A MUNICIPAL CORPORATION, APPROVING THE FY-2015-2016 BUDGET, AUTHORIZING THE CITY MANAGER TO TRANSFER UNEXPENDED AND UNENCUMBERED APPROPRIATIONS AND ESTABLISHING BUDGET AMENDMENT AUTHORITY.**

**WHEREAS,** The City of Nowata adheres to the provisions of the Oklahoma Municipal Budget Act (the Act) in 11 O.S. Sections 17-201 through 17-216; and

**WHEREAS,** The City Manager (chief executive officer) has prepared a budget for the fiscal year ending June 30, 2016 (FY 2015-2016) consistent with the Act; and

**WHEREAS,** Section 17-215 of the Act, provides for the chief executive officer of the City, or designee, as authorized by the governing body, to transfer any unexpended and unencumbered appropriation from one department to another within the same fund; and

**WHEREAS,** The budget was formally presented to the Nowata City Board of Commissioners at least (30) days prior to the start of the fiscal year in compliance with Section 17-205; and

**WHEREAS,** The Nowata City Board of Commissioners has conducted a Public Hearing at least fifteen (15) days prior to the start of the fiscal year in compliance with Section 17-205; and

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE CITY OF NOWATA, STATE OF OKLAHOMA** that notice is hereby given that on the ( ) day of June, 2015, the City of Nowata adopted the FY 2015-2016 budget with total resources available in the amount of **\$3,446,565** and total fund/departmental appropriations in the amount of **\$3,095,200** Legal appropriations (spending/encumbering limits) are hereby established as follows:
