**WHEREAS**, this proposed budget has been filed with the Secretary, and the budget, upon adoption, will be filed with the State Auditor and Inspector; and

**WHEREAS**, The City Council and Trustees have determined it to be in the best interest of the city to adopt the proposed budget for the 2024-2025 Fiscal Year as discussed, and




