## **NOTICE OF PUBLIC HEARING**

**2019 - 2020 BUDGET**

**BUDGET ADOPTION RESOLUTION  
ARCADIA, OKLAHOMA**

**RESOLUTION NUMBER 0620-19**

**A RESOLUTION APPROVING THE TOWN OF ARCADIA, OKLAHOMA BUDGET FOR  
THE FISCAL YEAR 2019-2020 AND ESTABLISHING BUDGET AMENDMENT AUTHORITY.**

**WHEREAS**, the Town of Arcadia has adopted the provision of the Oklahoma Municipal Budget Act (The Act) applicable to budgeting by purpose in 11 O.S. Section 17-201 through 17-216; and

**WHEREAS**, the Town of Arcadia is required by such Act to prepare a fiscal year budget containing he estimated and actual income of revenue of the Town and the appropriations of that income and revenue by purpose; and

**WHEREAS**, the Chief Executive Officer has prepared a budget for the fiscal year ending June 30, 2020 (FY 2019-2020) consistent with the Act for the Town of Arcadia, excluding all legally-separate public trusts or authorities of which the Town is beneficiary; and

**WHEREAS**, the Act in Section 17-215 provides for the Chief Executive Officer of the Town or designee, as authorized by the governing body, to transfer ant unexpended and unencumbered appropriation from one purpose to another; and


**WHEREAS**, the budget has been formally presented to the Town of Arcadia at least 30 days prior to the start of the fiscal year in compliance with Section 17-205; and


**WHEREAS**, the Town of Arcadia has conducted a Public Hearing at least 15 days prior to the start of the fiscal year, and published notice of Public Hearing in compliance with Section 17-208 of The Act; and

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN  
OF ARCADIA, OKLAHOMA;**

**SECTION I.** The Board of Trustees of the Town of Arcadia does hereby adopt the FY 2019-2020 Budget on the 20<sup>th</sup> day of June, 2019 with total income and revenues provided in the amount of \$556,795.00. Legal appropriates (obligating/encumbering limits) are hereby established as follows:

**SECTION 2.** All transfers of appropriation between purpose, supplemental appropriations of decrease in the total appropriations shall be adopted at a meeting of the Board of Trustees with the State Auditor Inspector.

**A Public Hearing on the annual budgets for fiscal year 2019-2020 shall be held at Town Hall on Thursday, June 20, 2019 as follows:**


