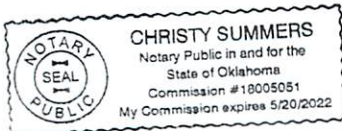

RESOLUTION NO. 2020-05-01

**A RESOLUTION OF THE TOWN OF AVANT, A MUNICIPAL CORPORATION,
APPROVING THE ANNUAL BUDGET FOR THE FISCAL YEAR 2020-2021 AND
ESTABLISHING BUDGET AMENDMENT AUTHORITY**

WHEREAS, the Town of Avant has adopted the provisions of the Oklahoma Municipal Budget Act (the Act) in 11 O.S. Sections 17-201 through 17-216; and

WHEREAS, the Mayor and Town Clerk have prepared a budget for the fiscal year ending June 30, 2021 (FY 2020-2021) consistent with the Act; and

WHEREAS, the budget has been formally presented to the Board of Trustees at least thirty (30) days prior to the start of the fiscal year in compliance with Section 17-205; and

WHEREAS, the Board of Trustees has conducted a Public Hearing at least fifteen (15) days prior to the start of the fiscal year, and published notice of the Public Hearing in compliance with Section 17-208 of the Act.


**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES MEETING IN
REGULAR SESSION ON THIS 18TH DAY OF MAY, AS FOLLOWS, TO-WIT:**

SECTION 1. The Board of Trustees of the Town of Avant does hereby adopt the FY 2020-2021 Budget on this 18th day of June, 2020 as provided by Exhibit A, attached hereto and incorporated herein by reference.




