ORDINANCE NO. 43

"AN ORDINANCE PROVIDING
FOR THE CLOSING OF A PORTION OF SECOND A VENUE
BETWEEN FOURTH STREET
AND SIXTH STREET, A PORTION OF FIFTH STREET BETWEEN THIRD A VENUE AND
THE RAILROAD RIGHT OF
WAY, ALL OF THE ALLEYS IN
BLOCKS 40 AND

45, A PORTION OF THE AL-LEYS IN BLOCKS 41 AND 44, ORIGINAL TOWN OF HAL-LETT, IN THE TOWN OF HAL-LETT, PAWNEE COUNTY, STATE OF OKLAHOMA, AS PLATTED AND DECLARING AN EMERGENCY."

BE IT ORDAINED BY THE MAYOR AND THE TOWN TRUSTEES OF THE TOWN OF HALLETT OKLAHOMA:

SECTION 1: That a portion of Second Avenue between Fourth Street and Sixth Street, a portion of Fifth Street between Third Avenue and the Railroad Right of Way, all of the alleys in Blocks 40 and 45, and a portion of the alleys in Blocks 41 and 44, all in the Original Town of Hallett, Pawnee County, State of Oklahoma, as platted shall be closed to thru traffic, more particularly described as follows:

Second Avenue from the South Line of Fourth Street to the North Line of Sixth Street as platted

Fifth Street from West Line of Third Avenue to the East line of the Railroad Right of Way.

All of the alley in Block 40, Original Town of Hallett, State of Oklahoma, according to the recorded plat thereof.

All of the alley in Block 45, Original Town of Hallett, State of Oklahoma, according to the recorded plat thereof.

A portion of the alley in Block 41, Original Town of Hallett. State or Oklahoma, according to the recorded plat thereof more particularly described as follows: Beginning at the Southwest corner of Lot 7, Block 41, thence South 20 feet to the Northwest corner of Lot 18, Block 41, thence East and distance of 175.00 feet to the Northeast corner of Lot 24. Block

41, thence North a distance of 20 feet to the Southeast corner of Lot 1, Block 41, thence West a distance of 175.00 feet to the Point of Beginning.

All that portion of the alley in Block 44, Original Town of Hallett, State of Oklahoma, lying East of the East line of the Railroad Right of Way Line.

Provided that the Town retains the right to reopen the street or alley, at no cost to the Town, if it's determined to be necessary by the Town or if the property owners of more than 1/2 of the area touching the street or alley file an application requesting such street or alley to be reopened. Provided further that any improvements made to the area shall be completed solely at the cost of the owner of the adjacent property who elects to make such improvement and any such improvement shall be subject to removal in the event that such street or alley is reopened.

SECTION 2: Emergency Clause
It being immediately necessary for
the preservation of the peace, health
and safety, an emergency is hereby
declared to exist by reason whereof
this ordinance shall take effect and
be in full force and in effect from
and after its passage, approval and
publication.
