

NOW, THEREFORE BE IT RESOLVED BY THE COUNCIL MEMBERS OF THE TOWN OF FANSHAWE, OKLAHOMA.

SECTION 1. The Town Council does hereby adopt the FY 2016-2017 Budget on the 8th day of July, 2016, as presented in the attached budget, with totals for individual functions as listed in the attached budget within each fund.

SECTION 2. The Treasurer is authorized to make departmental transfers of appropriations as needed and payment of ordinary expenses with the approval from the Town Council.

SECTION 3. The Resolution and a copy of the adopted budget will be transmitted to the Oklahoma State Auditor and Inspector and one copy submitted to the Clerk of this municipality.


