TOWN OF FOYIL, ROGERS COUNTY, OKLAHOMA RESOLUTION NO. 2021 – 2

A RESOLUTION AMENDING THE TOWN OF FOYIL, OKLAHOMA, BUDGET FOR THE FISCAL YEAR 2020-2021 AND ESTABLISHING BUDGET AMENDMENT AUTHORITY

WHEREAS, The Town of Foyil has adopted the provisions of the Oklahoma Municipal Budget Act (the Act) in 11 O.S. Sections 17-201 through 17-216; and

WHEREAS, The Act in section 17-215 provides for the Mayor of the Town, or designee, as authorized by the governing body, to transfer any unexpended and unencumbered appropriation from one department to another within the same fund; and

WHEREAS, The Act in section 17-216 provides for amendment and supplemental appropriation where revenue is received from sources not anticipated in the budget year, and when revenue is received from known sources in excess of the budget estimates therefore; and

WHEREAS, The Town has received funds for establishment of a police department from the Foyil Economic Development Authority, and sales tax revenue significantly higher than budgeted; and

WHEREAS, a budget must be amended to allow for expenditures for the police department and for other personal services and other charges and expenditures.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF THE TOWN OF FOYIL, OKLAHOMA:

SECTION 1. The Board of the Town of Foyil does hereby AMENDS the FY 2020-2021 Budget with total resources available in the amount of \$380,000, and total fund/departmental appropriations in the amount of \$211,665. Legal appropriations (spending/encumbering limits) are hereby established as follows:

SECTION 2. The Board does hereby authorize the Mayor and Treasurer to transfer any unexpended and unencumbered appropriations, at any time throughout FY 2020-2021, from one line item to another, one object category to another within a department, or one department to

another within a fund, without further approval by the Town Board.

SECTION 3. All supplemental appropriations or decrease in the total appropriation of a fund shall be adopted at a meeting of the Town Board and filed with the State Auditor and Inspector.

SECTION 4. The Town Mayor and Treasurer are authorized to file the approved budget, as amended, with the State Auditor and Inspector as required by law.
