

DIRECTION TO COUNTY EXCISE BOARDS CONCERNING ANNUAL FIVE (5) MILL TAX LEVY COMMENCING JULY 1, 2016, FOR TULSA TECHNOLOGY CENTER SCHOOL DISTRICT NO. 18, D/B/A TULSA TECHNOLOGY CENTER. (THREE (3) MILLS) AND TULSA COMMUNITY COLLEGE TECHNOLOGY CENTER SCHOOL DISTRICT, A/K/A TULSA COMMUNITY COLLEGE (TWO (2) MILLS).

As amended by Sections 97 and 155 of House Bill 1214 of the 2001 Regular Session of the Oklahoma Legislature, effective July 1, 2001 (OKLA. STAT. tit. 70, §14-108(B))(2011), the official name of a technology center school district shall be designated by the State Board of Career and Technology Education. Pursuant to said statutes, the official name of said School District has been changed to Tulsa Technology Center School District No. 18, d/b/a Tulsa Technology Center. The Board of Education of the School District adopted said name as the official name for the School District at the Regular Meeting of said Board of Education on June 24, 2002, following approval by the Oklahoma Legislature as reflected in Sections 2 and 3 of Senate Bill 1287 of the 2002 Regular Session of the Oklahoma Legislature, effective June 6, 2002 (OKLA. STAT. tit. 70, §§ 4419 and 4420 (2011)). Accordingly, the official name of the School District, formerly known as Tulsa County Technology Center School District No. 18, d/b/a Tulsa Technology Center, is now Tulsa Technology Center School District No. 18, d/b/a Tulsa Technology Center).

I

BOARD MEMBER ELECTION FOR BOARD DISTRICT NO. 5 (ZONE 5)

WHEREAS, the term of office of the Member of the Board of Education of Tulsa Technology Center School District No. 18, d/b/a Tulsa Technology Center, representing **Board District No. 5 (Zone 5)** expires on **Tuesday**, **February 9, 2016**; and

WHEREAS, it is necessary to conduct an election on Tuesday, February 9, 2016, to select a person from among the candidates who reside in Board District No. 5 (Zone 5) to be a Board Member of Tulsa Technology Center School District No. 18, d/b/a Tulsa Technology Center; and

WHEREAS, OKLA. STAT. tit. 26, §13A-105 (2011), provides that candidates for the office of member of the board of education for school districts located in more than one county may file their written declaration of candidacy with the county election board of either the county wherein supervision of the school district is located or the county wherein the candidate resides during a filing period beginning on the first Monday in December and ending on the following Wednesday; and

WHEREAS, supervision of Tulsa Technology Center School District No. 18, d/b/a Tulsa Technology Center, is located in Tulsa County, Oklahoma; and

WHEREAS, **Board District No. 5 (Zone 5)** is located partially in Tulsa County, Oklahoma, partially in Creek County, Oklahoma, partially in Pawnee County, Oklahoma, partially in Osage County, Oklahoma, and partially in Washington County, Oklahoma; and

WHEREAS, as required by OKLA. STAT. tit. 26, §13A-105 (2011) the declaration of candidacy shall be signed by the candidate and shall have an attachment signed by the candidate listing the requirements of a candidate for election or re-election to a school board as set forth in OKLA. STAT. tit. 26, § 13A-106 (2011), OKLA. STAT. tit. 26, § 5-105a (2011), OKLA. STAT. tit. 70, §§ 5-110 (2014 Supp.), 5-110.1 (2014 Supp.), and 5-113 (2011), and the candidate shall swear or affirm that he or she is eligible to run for such office or serve in such office if elected; and

WHEREAS, pursuant to OKLA. STAT. tit. 26, §13A-109 (2011), it is the duty of the Board of Education of Tulsa Technology Center School District No. 18, d/b/a Tulsa Technology Center, to call the election for the above purposes and to state in its Resolution calling for said election the following: the date or dates of the election; the identification of the office or offices to be filled, qualifications of candidates for office and the length of term of each; to fix the place

or places where such election will be held; information describing election districts within the school district in which the election will be held; ballot titles of the question or questions to be voted upon; information describing the persons eligible to vote in the election; and all other information necessary for conducting the election or elections.

NOW THEREFORE, BE IT RESOLVED by the Board of Education of Tulsa Technology Center School District No. 18, d/b/a Tulsa Technology Center, as follows:

1. Notice, Call and Proclamation of Board Member Election For Election District No. 5 (Zone 5). An election is hereby called for Board District No. 5 (Zone 5) of Tulsa Technology Center School District No. 18, d/b/a Tulsa Technology Center, to be held on FEBRUARY 9, 2016, between the hours of 7:00 a.m. and 7:00 p.m. on said date, at which election the eligible voters of Board District No. 5 (Zone 5) of Tulsa Technology Center School District No. 18, d/b/a Tulsa Technology Center, shall select a Board of Education member for Election District No. 5 (Zone 5) for Tulsa Technology Center School District No. 18, d/b/a Tulsa Technology Center, to represent Board District No. 5 (Zone 5) on said Board of Education for a term of seven (7) years commencing on the first regular, special or emergency meeting of the Board of Education of said School District after the election and expiring with the regular school election in 2023. THIS RESOLUTION SHALL CONSTITUTE THE NOTICE, CALL AND PROCLAMATION OF SAID ELECTION.

If no candidate receives more than fifty percent (50%) of the votes cast for the Board of Education member to represent said Board District, a runoff election in Board District No. 5 (Zone 5) for the two candidates with the highest number of votes shall be conducted on APRIL 5, 2016, and shall be conducted in the same manner as the FEBRUARY 9, 2016, election with reference to polling places, qualification of electors, conduct of elections, ballots and election

expenses. THIS RESOLUTION SHALL CONSTITUTE THE NOTICE, CALL AND PROCLAMATION OF SAID RUNOFF ELECTION ON APRIL 5, 2016, IF AND ONLY IF SAID RUNOFF ELECTION IS NECESSARY UNDER THE FOREGOING.

- Qualifications of Electors for Board District No. 5 (Zone 5). Any person shall be eligible to vote in the election for Member of the Board of Education of Tulsa Technology Center School District No. 18, d/b/a Tulsa Technology Center, from Board District No. 5 (Zone 5) if such person is registered as a voter with the county election board of the county in which the person resides at an address located within the geographical boundaries of Board District No. 5 (Zone 5) as described on **EXHIBIT A** attached hereto and made a part hereof and as reflected on **EXHIBIT B** attached hereto and made a part hereof. Only qualified voters who reside within that portion of a voting precinct which is located within Board District No. 5 (Zone 5) are eligible to vote.
- 3. Candidates. Any person desiring to become a candidate for the Board of Education of Tulsa Technology Center School District No. 18, d/b/a Tulsa Technology Center, from Board District No. 5 (Zone 5) and who resides within the geographical boundaries of Board District No. 5 (Zone 5) in Tulsa County shall file a written Declaration of Candidacy as stated above with the Tulsa County Election Board during the filing period commencing at 8:00 a.m. on **DECEMBER 7, 2015**, and ending at 5:00 p.m. on **DECEMBER 9, 2015**. Any person desiring to become a candidate for the Board of Education of Tulsa Technology Center School District No. 18, d/b/a Tulsa Technology Center, from Board District No. 5 (Zone 5) and who resides within the geographical boundaries of Board District No. 5 (Zone 5) in Creek County shall file a written Declaration of Candidacy as stated above with either the Tulsa County Election Board or the Creek County Election Board during the filing period commencing at 8:00

a.m. on DECEMBER 7, 2015, and ending at 5:00 p.m. on DECEMBER 9, 2015. Any person desiring to become a candidate for the Board of Education of Tulsa Technology Center School District No. 18, d/b/a Tulsa Technology Center, from Board District No. 5 (Zone 5) and who resides within the geographical boundaries of Board District No. 5 (Zone 5) in Pawnee County shall file a written Declaration of Candidacy as stated above with either the Tulsa County Election Board or the Pawnee County Election Board during the filing period commencing at 8:00 a.m. on DECEMBER 7, 2015, and ending at 5:00 p.m. on DECEMBER 9, 2015. Any person desiring to become a candidate for the Board of Education of Tulsa Technology Center School District No. 18, d/b/a Tulsa Technology Center, from Board District No. 5 (Zone 5) and who resides within the geographical boundaries of Board District No. 5 (Zone 5) in Osage County shall file a written Declaration of Candidacy as stated above with either the Tulsa County Election Board or the Osage County Election Board during the filing period commencing at 8:00 a.m. on DECEMBER 7, 2015, and ending at 5:00 p.m. on DECEMBER 9, 2015. Any person desiring to become a candidate for the Board of Education of Tulsa Technology Center School District No. 18, d/b/a Tulsa Technology Center, from Board District No. 5 (Zone 5) and who resides within the geographical boundaries of Board District No. 5 (Zone 5) in Washington County shall file a written Declaration of Candidacy as stated above with either the Tulsa County Election Board or the Washington County Election Board during the filing period commencing at 8:00 a.m. on DECEMBER 7, 2015, and ending at 5:00 p.m. on DECEMBER 9, 2015. To be eligible to file as a candidate, the person filing must have been: (i) a registered voter registered with a County Election Board at an address located within the geographical boundaries of the Election District for which the person files a Declaration of Candidacy for six (6) months preceding the first day of the filing period (DECEMBER 7, 2015); and (ii) must have resided in

the Election District for which the person files a Declaration of Candidacy for at least six (6) months preceding the first day of the filing period (DECEMBER 7, 2015). No person shall be eligible to be a candidate for or elected to be a member of the Board of Education unless the person has been awarded a high school diploma or certificate of high school equivalency. A candidate may not be related to an employee of Tulsa Technology Center School District No. 18, d/b/a Tulsa Technology Center, or to a Member of the Board of Education of Tulsa Technology Center School District No. 18, d/b/a Tulsa Technology Center, within the second degree by blood or marriage. A candidate cannot have been convicted of, or entered a plea of guilty or no contest to, a misdemeanor involving embezzlement or a felony and it presently be within fifteen (15) years of the completion of the sentence or during the pendency of an appeal of such conviction or plea. If the candidate is not an incumbent member of the Board of Education, the candidate must agree and pledge in writing when the candidate files the candidate's Notification and Declaration of Candidacy that the candidate will complete at least twelve (12) hours of instruction, within fifteen (15) months of election, on educational issues in the following areas: school finance, legal issues, which include but are not limited to employment, due process, new laws, the Oklahoma Open Records Act and the Oklahoma Open Meeting Act; and duties and responsibilities, which include but are not limited to special education and ethics, of district board of education members. Each elector shall agree and pledge in writing to complete at least one (1) hour of instruction in school finance, one (1) hour of instruction in the Oklahoma Open Records Act and the Oklahoma Open Meeting Act and one (1) hour of instruction in ethics. The remaining hours may be satisfied by attending a two-day workshop to be held within the state by the State Department of Education, by the Oklahoma Department of Career and Technology Education, or by attending workshops, seminars or classes which address the above-mentioned

subject matter, and which are sponsored by the any organization approved by the State Board of Education, including but not limited to institutions of higher education. If the candidate is an incumbent member of the Board of Education, in his or her Notification and Declaration of Candidacy, the candidate must agree and pledge in writing that upon reelection the candidate will complete six (6) hours of instruction, within fifteen (15) months of election, including one (1) hour of instruction in school finance, one (1) hour of instruction in the Oklahoma Open Records Act and the Oklahoma Open Meeting Act, and one (1) hour of instruction in ethics. The remaining hours may be satisfied by attending workshops, seminars or classes addressing educational issues approved for credit by the Oklahoma State Board of Education. If a member has not satisfied the above instructional requirements within fifteen (15) months of his or her election, the local board of education shall declare the seat of such member vacant and fill the vacancy according to law. The candidate elected to the board must also complete an additional twenty-one (21) hours of continuing education prior to the date set for filing for reelection to the member's respective board seat. If the candidate has served a full term of office as a member of the Board of Education and if the candidate has failed to attend a minimum of twenty-one (21) hours of continuing education courses, workshops, seminars, conferences and conventions within this state which satisfy the continuing education requirement and which are approved jointly by the Oklahoma State Department of Education and the State Board of Career and Technology Education, the candidate is ineligible to run for reelection to the Board of Education to that respective board seat on Board of Education or to run for election to any other board seat on the Board of Education for four (4) years.

4. <u>If Only One Candidate</u>. If within the filing period, only one (1) person files a Declaration of Candidacy for Election District No. 5 (Zone 5), that person shall be deemed to

have been elected to the office for that Election District and no Nomination Election shall be held for such office.

- 5. <u>Ballots</u>. The legal names of the candidates shall be placed on the election ballots according to lot as determined by the Tulsa County Election Board.
- 6. <u>Term of Office</u>. The term of the member of the Board of Education elected to represent Election District No. 5 (Zone 5) shall commence on the first regular, special or emergency Board of Education meeting after the election.
- 7. Polling Places. Pursuant to the authority vested in the Board of Education of Tulsa Technology Center School District No. 18, d/b/a Tulsa Technology Center, by Oklahoma law to fix the place or places where such election shall be held, the Board of Education of Tulsa Technology Center School District No. 18, d/b/a Tulsa Technology Center, hereby designates polling places for said election as determined by the Tulsa County Election Board and by the respective county election boards of the other counties having territory included within the geographical boundaries of Tulsa Technology Center School District No. 18, d/b/a Tulsa Technology Center.
- 8. <u>Conduct of Elections</u>. Said elections shall be conducted by the Tulsa County Election Board in accord with Oklahoma laws. The election officials (Judge, Inspector and Clerk) at the polling places shall be the election officials designated for such purpose by the Tulsa County Election Board or by the county election board of the county in which the precinct is located. The precinct polling places shall be open between the hours of 7:00 a.m. and 7:00 p.m. on the date of the elections.
- 9. <u>Precinct Registry</u>. Persons eligible to vote shall sign, in the presence of the election clerk, the proper precinct registry before being issued a ballot. The voter's signature on

said precinct registry shall be the best evidence of said voter having voted at said election. The precinct registry shall be on file with the Office of the Secretary of the County Election Board and shall be open to public inspection during regular office hours; provided, however, that such precinct registry may be destroyed by the Secretary of the County Election Board at the end of twenty-two (22) months from the date of the election. Any person willfully voting illegally or found guilty of casting more than one vote in such election shall be deemed guilty of a felony and upon conviction be confined in the State Penitentiary for not more than two (2) years, or fined not more than Five Thousand Dollars (\$5,000), or both.

- Election Expenses. Tulsa Technology Center School District No. 18, d/b/a Tulsa Technology Center, shall reimburse the Tulsa County Election Board for the expense of conducting said election. In the event that a school district election or other election other than the election called for in this Resolution is held on **FEBRUARY 9, 2016**, concurrently at the same polling places, the costs of the election shall be reimbursed to the Tulsa County Election Board on a proportionate basis as provided by OKLA. STAT. tit. 26, §13A-111(B) (2011).
- 11. Notice. Notice of said election shall be given by the Clerk of the Board of Education of Tulsa Technology Center School District No. 18, d/b/a Tulsa Technology Center, by publishing a legal notice for each regular and special election in one issue of a legal newspaper of the county, as defined by OKLA. STAT. tit. 25, §106 (2011) in each county wherein the school district is a member of Tulsa Technology School District No. 18, d/b/a Tulsa Technology Center at least ten (10) days prior to the filing period. Additionally, Tulsa Technology School District No. 18, d/b/a Tulsa Technology Center shall issue a news release of the upcoming filing period and election to a newspaper of general circulation in each county wherein the school district is a member of Tulsa Technology School District No. 18, d/b/a Tulsa

Technology Center. The legal notice and press release shall include, but shall not be limited to, the dates of the filing period for the election or elections and the office or offices to be filled. The notice shall also be posted in each county at Tulsa Technology School District No. 18, d/b/a Tulsa Technology Center administrative offices, if such office exists in the county, and county election board office in each county.

- 12. <u>Absentee Voting</u>. Any qualified person shall be allowed to vote by absentee or in-person absentee ballot pursuant to Oklahoma law.
- The territorial limits of Tulsa Technology Center School District No. 18, d/b/a Tulsa Technology Center, are coterminous with the County of Tulsa and that part of the boundaries of school districts located partially in Tulsa County that extend into the seven (7) adjacent counties. A legal description of the territory comprising Board District No. 5 (Zone 5) is attached hereto as **EXHIBIT A**. A map reflecting the boundaries of Board District No. 5 (Zone 5) is attached hereto as **EXHIBIT B**. A legal description of the territory included within Tulsa Technology Center School District No. 18, d/b/a Tulsa Technology Center, may be obtained from any of the following: (a) Office of the Superintendent, Tulsa Technology Center School District No. 18, d/b/a Tulsa Technology Center, 5111 East Skelly Drive, Tulsa, Oklahoma; or (b) Tulsa County Election Board, 555 North Denver, Tulsa, Oklahoma; or (c) State Board of Career and Technology Education, 2500 North Lincoln Boulevard, Oklahoma City, Oklahoma 73105-4199.
- 14. <u>Miscellaneous</u>. A copy of this Resolution shall be personally served on the Office of the Tulsa County Election Board on or before **NOVEMBER 20, 2015**.

DIRECTION TO COUNTY EXCISE BOARDS CONCERNING ANNUAL FIVE (5) MILL BUILDING FUND MILLAGE LEVY COMMENCING JULY 1, 2016, FOR TULSA TECHNOLOGY CENTER SCHOOL DISTRICT NO. 18, D/B/A TULSA TECHNOLOGY CENTER

WHEREAS, pursuant to Article X, Section 10 of the Oklahoma Constitution, Tulsa Technology Center School District No. 18, d/b/a Tulsa Technology Center, may make a Building Fund Millage Levy which may be used for erecting, remodeling, repairing or maintaining school buildings, and for purchasing furniture, equipment and software for instructional and noninstructional purposes, for purchasing energy and telecommunications utilities, for paying fire and casualty insurance premiums for school facilities, and for purchasing security systems, and for paying salaries of security personnel, or for one or more, or all, of such purposes, in an amount not to exceed five (5) mills on the dollar of the assessed value of the taxable property in Tulsa Technology Center School District No. 18, d/b/a Tulsa Technology Center; and

WHEREAS, on February 13, 2001, the Board of Education of Tulsa Technology School District No. 18, d/b/a Tulsa Technology Center, submitted to the electors of this School District a question pursuant to State Question 690 providing that the five (5) mill Building Fund Millage Levy pursuant to Article X, Section 10 of the Oklahoma Constitution, as amended, shall be made each fiscal year after approval of the levy by a majority of the electors of the School District voting on the question until such time as the making of the levy permanent is rescinded by law;

WHEREAS, at said election on February 13, 2001, a majority of the electors of this School District voted to approve making the five (5) mill Building Fund Millage Levy permanent until such approval is rescinded as authorized by State Question 690;

WHEREAS, no petition signed by the electors of said School District, or recommendation of the Board of Education of said School District requesting an election to rescind said five (5) Mill Building Fund Millage Levy, has been made;

NOW THEREFORE, BE IT RESOLVED, that the Excise Boards of the various Counties having jurisdiction over the territory of said Board of Education are directed to make a five (5) Mill Building Fund Millage Levy for said School District for the 2016-2017 fiscal year, commencing July 1, 2016.

DIRECTION TO TULSA COUNTY EXCISE BOARD CONCERNING FIVE (5) MILL LOCAL INCENTIVE TAX LEVY COMMENCING JULY 1, 2016, FOR GENERAL OPERATIONAL PURPOSES FOR TULSA COMMUNITY COLLEGE TECHNOLOGY CENTER SCHOOL DISTRICT, A/K/A TULSA COMMUNITY COLLEGE

WHEREAS, pursuant to OKLA. STAT. tit. 70, § 4420 (2011), the Board of Education of Tulsa Technology Center School District No. 18, d/b/a Tulsa Technology Center, is the "Funding Board" for Tulsa Community College Technology Center School District, a/k/a Tulsa Community College; and

WHEREAS, Article X, Section 9B(B) of the Oklahoma Constitution, as amended by Laws, 1993, Chapter 149, Section 1, provides that in addition to any other levies authorized by Article X, Section 9B, an area school district may make a local incentive levy for the benefit of the area school district in an amount not to exceed five (5) mills on the dollar valuation of the taxable property in the area school district. Said law further provides that this levy, when approved, shall be made each fiscal year thereafter until repealed by a majority of the electors of the area school district voting on the question at an election called for that purpose; and

WHEREAS, at an election duly called and held on February 8, 1994, a majority of the registered voters voting at said election approved a local incentive levy of five (5) mills on the dollar valuation of the taxable property in the Tulsa Community College Technology Center School District, a/k/a Tulsa Community College; and

WHEREAS, no election has been held or has been called to repeal said local incentive levy of five (5) mills for the benefit of Tulsa Community College Technology Center School District, a/k/a Tulsa Community College.

NOW THEREFORE, BE IT RESOLVED, by the Board of Education of Tulsa Technology Center School District No. 18, d/b/a Tulsa Technology Center, the "Funding Board" for the Tulsa Community College Technology Center School District, a/k/a Tulsa Community College, that pursuant to Article X, Section 9B(B) of the Oklahoma Constitution, the Tulsa County Excise Board is directed to make a five (5) mill local tax incentive levy, in addition to all other levies otherwise provided by law, upon the dollar valuation of the taxable property within the Tulsa Community College Technology Center School District, a/k/a Tulsa Community College, for the general operational purposes of the Tulsa Community College Technology Center School District, a/k/a Tulsa Community College, for the fiscal year beginning July 1, 2016, provided that said millage rate shall be adjusted as provided in subsection (b) of Section 8A of Article X of the Oklahoma Constitution.

NOW THEREFORE, BE IT RESOLVED, by the Board of Education of Tulsa Technology Center School District No. 18, d/b/a Tulsa Technology Center, that pursuant to Article X, Section 9B(B) of the Oklahoma Constitution, the County Excise Boards having jurisdiction over the property included within the territory of Tulsa Technology Center School District No. 18, d/b/a Tulsa Technology Center, are directed to make a five (5) mill local tax

incentive levy, in addition to all other levies otherwise provided by law, upon the dollar valuation of the taxable property within the Tulsa Technology Center School District No. 18, d/b/a Tulsa Technology Center, for the general operational purposes of the Tulsa Technology Center School District No. 18, d/b/a Tulsa Technology Center, for the fiscal year beginning July 1, 2016, provided that in those counties where household goods of heads of families and livestock have been exempted from ad valorem taxation as provided by subsection (b) of Section 6 of Article X of the Oklahoma Constitution, the millage rate shall be adjusted as provided by subsection (b) of Article X of the Oklahoma Constitution.

DIRECTION TO COUNTY EXCISE BOARDS CONCERNING ANNUAL FIVE (5) MILL TAX LEVY COMMENCING JULY 1, 2016, FOR

TULSA TECHNOLOGY CENTER SCHOOL DISTRICT NO. 18, D/B/A TULSA TECHNOLOGY CENTER (Three (3) Mills); AND FOR

TULSA COMMUNITY COLLEGE TECHNOLOGY CENTER SCHOOL DISTRICT, <u>A/K/A TULSA COMMUNITY COLLEGE (Two (2) Mills)</u>

WHEREAS, Article X, Section 9B(A) of the Oklahoma Constitution, as amended by Laws, 1993, Chapter 149, Section 1, provides that in addition to any other levies authorized by Article X, Section 9B, an area school district may make an annual tax levy for the benefit of the area school district in an amount not to exceed five (5) mills on the dollar valuation of the taxable property in the area school district when approved by a majority of those registered voters of the area school district voting on the question at an election called for that purpose. Said law further provides that this levy, when approved, shall be made each fiscal year thereafter until repealed by a majority of the electors of the area school district voting on the question at an election called for that purpose; and

WHEREAS, pursuant to Section 3 of Senate Bill 1287 of the 2002 Regular Session of the Oklahoma Legislature (OKLA. STAT. tit. 70, § 4420(B) (2011)), up to five (5) mills on the dollar valuation of the taxable property in the Tulsa Community College Technology Center School District, a/k/a Tulsa Community College, levied under Article X, Section 9B(A) of the Oklahoma Constitution may be allotted, budgeted and expended as a part of the educational and general operating budget of Tulsa Community College Technology Center School District, a/k/a Tulsa Community College; and

WHEREAS, pursuant to Section 2 of Senate Bill 1287 of the 2002 Regular Session of the Oklahoma Legislature (OKLA. STAT. tit. 70, §4419(C) (2011)), up to five (5) mills on the dollar valuation of the taxable property in the Tulsa Technology Center School District No. 18, d/b/a Tulsa Technology Center, levied under Article X, Section 9B(A) of the Oklahoma Constitution may be allotted, budgeted and expended as a part of the educational and general operating budget of Tulsa Technology Center School District No. 18, d/b/a Tulsa Technology Center.

NOW THEREFORE, BE IT RESOLVED, by the Board of Education of Tulsa Technology Center School District No. 18, d/b/a Tulsa Technology Center, that pursuant to Article X, Section 9B(A) of the Oklahoma Constitution, the County Excise Boards having jurisdiction over the property included within the territory of Tulsa Technology Center School District No. 18, d/b/a Tulsa Technology Center, are directed to make a three (3) mill tax levy, in addition to all other levies otherwise provided by law, upon the dollar valuation of the taxable property within the Tulsa Technology Center School District No. 18, d/b/a Tulsa Technology Center, for the general operational purposes of the Tulsa Technology Center School District No. 18, d/b/a Tulsa Technology Center, for the fiscal year beginning July 1, 2016, and the Tulsa

County Excise Board is directed to make a two (2) mill tax levy, in addition to all other levies otherwise provided by law, upon the dollar valuation of the taxable property within the Tulsa Community College Technology Center School District, a/k/a Tulsa Community College, for supplemental support of the post-secondary vocational and/or technical and/or adult education programs of Tulsa Community College Technology Center School District, a/k/a Tulsa Community College, for the fiscal year beginning July 1, 2016, provided that in those counties where household goods of heads of families and livestock have been exempted from ad valorem taxation as provided by subsection (b) of Section 6 of Article X of the Oklahoma Constitution, the millage rate shall be adjusted as provided by subsection (b) of Article X of the Oklahoma Constitution.
