AN ORDINANCE AMENDING THE FISCAL YEAR 2019-20 BUDGET OF THE CITY OF TULSA, OKLAHOMA, BE AND IT IS HEREBY AMENDED TO MAKE SUPPLEMENTAL APPROPRIATIONS OF SEVENTY-FIVE THOUSAND DOLLARS (\$75,000.00) FROM REVENUES RECEIVED WITHIN THE TULSA STADIUM IMPROVEMENT DISTRICT FUND (FUND NO. 141), AS FOLLOWS:



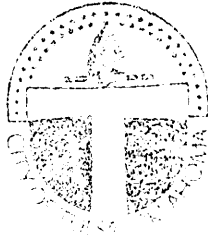


