

### Background Information

The City of Tulsa received \$30,923,815.75 in Coronavirus Relief Funds from the Oklahoma Office of Management and Enterprise Services. Prior budget actions have appropriated \$7,699,120 for projects with the Pandemic Relief Fund (Fund 166) with a transfer from the General Fund (Fund 100). This action will appropriate \$3,524,192 in the Pandemic Relief Fund (Fund 166) for the continuation of the homeless response operations and for facility safety modifications (detail description attached).

This action will also transfer the balance of the relief funds, \$23,224,697.75, from the General Fund (Fund 100) to the Pandemic Relief Fund (Fund 166).

### Background Information

At FY20 year-end, some contracts/requisitions were in process. Staff identified those that needed to be carried forward and included them in the FY21 budget. However, some items that were anticipated to meet the year-end purchasing deadline were not able to be purchased in time and the appropriations lapsed at year-end. This budget amendment will re-appropriate those funds to allow the purchases to continue.

General Government - \$400,000 for attorney fees; Police - \$155,000 for community policing, \$76,850 for gas masks, voice modulators, and cabling for new radios, \$30,000 for engine overhaul of helicopter, \$27,248 for Leads subscription.



**Policy Statement**

**Background Information**

This action will appropriate \$500,000 of revenue within the 2020 Sales Tax Fund (Fund 409) to the Greenwood Cultural Center Rehab project.

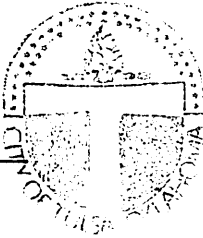
