**WHEREAS**, the Jenks Public Works Authority had unexpended unencumbered cash balances on hand at the end of fiscal year 2018-2019; and



**WHEREAS**, the Jenks Public Works Authority had unexpended unencumbered cash balances on hand at the end of fiscal year 2018-2019; and





**WHEREAS**, the Jenks Public Works Authority has received a reimbursement check from the insurance company for the replacement of the vehicle; and






