## RESOLUTION NO. 202-06-01

A RESOLUTION OF THE TOWN OF COPAN, A MUNICIPAL CORPORATION, APPROVING THE ANNUAL BUDGET FOR THE FISCAL YEAR 2021-2022 AND ESTABLISHING BUDGET AMENDMENT AUTHORITY.

WHEREAS, the Town of Copan has adopted the provisions of the Oklahoma Municipal Budget Act (the Act) in 11 O.S. Sections 17-201 through 17-216; and

WHEREAS, the Town Mayor and Town Clerk have prepared a budget for the fiscal year ending June 30, 2021 (FY 2021-2022) consistent with the Act; and

WHEREAS, the Town Council has conducted a Public Hearing at least fifteen (15) days prior to the adoption of this Resolution, and published notice of the Public Hearing in compliance with Section 17-208 of the Act.

NOW. THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL MEETING IN REGULAR SESSION ON THIS 15<sup>TH</sup> DAY OF JUNE, 2021, AS FOLLOWS, TO-WIT:

SECTION 1. The Town Council of the Town of Copan does hereby adopt the FY 2021-2022 Budget on this 15th day of June, 2021 on file with the Town Clerk, and incorporated herein by reference.

SECTION 2. All supplemental appropriations or decrease in the total appropriation of a fund shall be adopted at a meeting of the Town Council and filed with the State Auditor and Inspector.
