SECTION 1. The Town Council of the Town of Copan does hereby adopt the FY 2022-2023 Budget on this 21st day of June, 2022 on file with the Town Clerk, and incorporated herein by reference.

SECTION 2. All supplemental appropriations or decrease in the total appropriation of a fund shall be adopted at a meeting of the Town Council and filed with the State Auditor and Inspector.
