**A RESOLUTION OF THE TRUSTEES OF THE DEWEY PUBLIC WORKS AUTHORITY
TRANSFERRING FUNDS FROM THE PUBLIC WORKS AUTHORITY ENTERPRISE
FUND TO THE GENERAL FUND**

WHEREAS, the Oklahoma Statutes provides that the lawful treasurer of any city or town, when authorized by the appropriate governing body by resolution, shall transfer monies from one fund to another fund, and

WHEREAS, the Dewey Public Works Authority recognizes the necessity of transferring the amount of \$100,000 from the Public Works Authority's Enterprise Fund to the General Fund, and

WHEREAS, the City Council also recognizes the amount had previously been budgeted for in the Fiscal Year 2015-2016 Budget.

NOW, THEREFORE BE IT RESOLVED by the Trustees of the Dewey Public Works Authority:

- A. That the City Treasurer is hereby given authority and is directed to transfer \$100,000 from the Public Works Authority's Enterprise Fund to the General Fund.
- B. That the City Treasurer shall keep records of the transaction, showing the amount transferred from each fund and distributed to each fund.
