Background

The Oklahoma Aeronautics Commission (the Commission) was created to encourage, foster, and assist in the development of aeronautics in Oklahoma and to encourage the establishment and maintenance of public airports. This includes the preservation and improvement of the state's 114 public airports, which make up the state's airport system; and the promotion of the aviation industry, one of the top ten employers in Oklahoma, providing 143,700 jobs.

The Oklahoma City Airport Trust (the Sponsor) applied for assistance from the Commission to reconstruct taxiways A, A-1, and A-3 at Wiley Post Airport due to deterioration and incompatible pavement strengths. The Commission committed \$163,684 to this \$2,782,987 project. The Sponsor pledged \$77,641 with the difference paid by the Federal Aviation Administration (FAA).

The Office of the State Auditor and Inspector issued a report related to project PWA-07-F on March 11, 2010. As a result of the audit finding issued in that report, the Sponsor sought amended engineering invoices from the project engineer for engineering costs specifically related to this project. These revised invoices were submitted to the Commission for partial reimbursement. The Sponsor opted not to seek reimbursement for the applicable advertising costs. The prior report should be read in conjunction with this report.

Purpose and Scope

This audit was conducted in response to the Commission's request.

The audit period covered was August 2, 2007 through July 16, 2009.

We conducted this performance audit in accordance with generally accepted government auditing standards. Those standards require that we plan and perform the audit to obtain sufficient, appropriate evidence to provide a reasonable basis for our findings and conclusions based on our audit objectives. We believe that the evidence obtained provides a reasonable basis for our findings and conclusions based on our audit objectives. This report is a public document pursuant to the Oklahoma Open Records Act (51 O.S. § 24A.1 et seq.), and shall be open to any person for inspection and copying.

Objective 1 - Determine whether the revised engineering and advertising invoices submitted by the Oklahoma City Airport Trust are in accordance with "Exhibit B-1 - Program Narrative" and "Exhibit B-2 - Project Costs" of the airport construction agreement (state project number PWA-07-F).

Conclusion

The revised engineering invoices submitted by the Sponsor are in accordance with "Exhibit B-1 – Program Narrative" and "Exhibit B-2 – Project Costs" of the airport construction agreement.

Because revised advertising invoices could not be obtained, the Sponsor has waived its request for reimbursement for the Commission's share of advertising costs.

Methodology

To accomplish our objective, we performed the following:

- Reviewed the airport construction agreement;
- Interviewed the airport manager and the project engineer;
- Reviewed all original and revised invoices submitted by the engineer;
- Documented the expenditure process related to the construction project; and
- Observed the completed project.

The following information has been presented at the request of management. Our objective was to determine whether revised engineering and advertising invoices submitted by the Oklahoma City Airport Trust (state project number PWA-07-F) were in accordance with "Exhibit B-1 – Program Narrative" and "Exhibit B-2 – Project Costs" of the airport construction agreement. Therefore, we did not conclude on the following schedule.
