

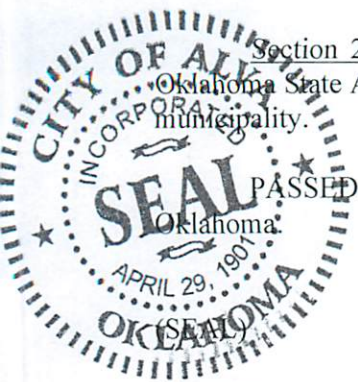



RESOLUTION NO. 2021-008

**A RESOLUTION OF THE CITY COUNCIL OF ALVA, MAINTAINING
AN INVESTMENT POLICY FOR THE CITY OF ALVA, OKLAHOMA
FOR THE FISCAL YEAR ENDING JUNE 30, 2022.**

WHEREAS, Title 62, Section 348.1 of the Oklahoma Statutes provides that the treasurer of any city or town, when authorized by the appropriate governing body by resolution, shall invest any monies in the custody of the treasurer as limited by law.

AND WHEREAS, the City Council of Alva recognizes the necessity of maintaining an investment policy to properly transact its investment activities.

AND WHEREAS, the City Council also recognizes the necessity of improving its procedures for investing available funds to earn additional revenue,

NOW, THEREFORE, BE IT RESOLVED by the City Council of Alva, Oklahoma as follows:


- A. That the Treasurer for the City of Alva shall be and is hereby given authority with direction from the Finance Committee to invest and reinvest available funds on a continuing basis during the fiscal year ending June 30, 2022; provided that the income received from said investments may be placed in the general fund of the governmental subdivision to be used for general governmental operations, the sinking fund, the building fund, or the fund from which the investment was made.
- B. That the Treasurer for the City of Alva shall keep records of all investments, showing the amount invested from each fund by type of investment and distribution of interest earned by each fund.
