For the purpose of complying with 19 O.S. § 171, we have performed the following procedures for December 10, 2008:

- Verify that equipment items on hand agree with inventory records as per 19 O.S. § 178.1.
- Verify that the amount of total claims approved for the operation of said Office is not in excess of limitations imposed by 19 O.S. § 347.
- Verify that a monthly report of the Office is on file with the County Clerk per 19 O.S. § 684.
- Verify that the Officers' depository account balances reconcile with the County Treasurer's records and that undeposited cash reconciles to receipts.

Information addressed in this report is the representation of the respective county officers.

Our county officer turnover engagement was limited to the statutory procedures described above and was less in scope than an examination or audit performed in accordance with auditing standards generally accepted in the United States of America, the objective of which would be the expression of an opinion. Accordingly, we do not express an opinion. Had we performed additional procedures, other matters might have come to our attention that would have been reported to you.

Based on our procedures performed, the amount of total claims approved for the operation of said Office was not in excess of limitations; the Officers' depository account balances reconciled with the County Treasurer's records and undeposited cash reconciled to receipts. With respect to equipment items agreeing with inventory records and current monthly report being on file with the County Clerk, our findings are included in the attached schedule of findings and responses.

This report is intended solely for the information and use of the management of the County and should not be used for any other purpose. This report is also a public document pursuant to the Oklahoma Open Records Act (51 O.S., section 24A.1 et seq.), and shall be open to any person for inspection and copying.

#### **Finding 2009-1 – Fixed Assets Inventory**

Criteria: Title 19 O.S. § 178.1 states, "The board of county commissioners in each county of this state shall take or cause to be taken, an inventory of all working tools, apparatus, machinery and equipment belonging to the county or leased or otherwise let to it or to any department thereof, other than that which is affixed to and made a part of lands and buildings, the cost of which as to each complete working unit thereof is more than Five Hundred Dollars (\$500.00), and thereafter, maintain or cause to be maintained a continuous inventory record...biennially thereafter, or oftener..."

Condition: We were unable to visually verify the following items on the County Clerk's inventory for the County Sheriff:

Effect: Inventory items were not accurately accounted for and the County's assets may not be safeguarded.

Recommendation: OSAI recommends the County investigate the missing items and adjust their inventory records accordingly. OSAI further recommends the County pass a resolution to document the approved disposition of the County's assets.

Views of responsible officials and planned corrective actions: The newly elected Sheriff, Gary Stanley and his staff, have recorded the fixed asset inventory items on forms #3511 and #3512 for filing with the County Clerk. Any items not identified will be adjusted by Resolution Disposing of Equipment. The Ford Expedition vehicle, which was considered a total loss, due to a traffic accident, was purchased by the insurance company. Resolution #R-09-07: Disposing of Junked Equipment, thereby properly recording disposition of this vehicle, has been approved by the County Commissioners.

Effect: Inventory items were not accurately accounted for and the County's assets may not be safeguarded.

Recommendation: OSAI recommends that a continuous inventory be maintained and updated to reflect additions and dispositions of all tools, apparatus, machinery, and equipment purchased, leased, or otherwise coming into custody of the County.

Views of responsible officials and planned corrective actions: Sheriff Stanley and his staff are working on adding the fixed asset items to the County inventory records by listing on forms #3511 and #3512 for recording with the County Clerk.

#### Finding 2009-4 – Monthly Report filed with Commissioners

Criteria: According to 19 O.S. § 684, it shall be the further duty of all such officers, boards, commissions and the members and employees of either thereof, to make and file with the county clerk on or before the second Monday of each month, a verified report in writing showing the several sources, classes and amounts of money received by virtue or under color of office during the preceding calendar month together with an itemized statement of the amount and purpose of all vouchers issued in disbursement distribution and transfer thereof.

Condition: We were able to verify the October monthly report, but the November report had not been filed at the time we performed our procedures.

Effect: The County Sheriff may not be in compliance with state statutes and safeguard controls are not being followed in a timely manner.

Recommendation: OSAI recommends the Sheriff's Office file the monthly reports by the second Monday of each Month.

Views of responsible officials and planned corrective actions: Sheriff Stanley has been made aware that the Monthly Report is to be filed in a timely manner and will see that this is done on a regular basis in the future.
