Waste, fraud and abuse result in added government costs and a reduction in services which impacts everyone. You can help by contacting us to express your concerns. By statute, we are able to respond to questions and concerns about public agencies, entities and individuals that gain inappropriately at your expense. As a state agency, we cannot investigate allegations against private businesses, entities or citizens except as it pertains to government funded contracts and purchases.

We CAN investigate the following areas upon request from the Governor, Attorney General, local district attorney, governing board, or by citizen petition:
