I have not audited or reviewed the accompanying financial statement and, accordingly, do not express an opinion or provide any assurance about whether the financial statement is presented in accordance with the State of Oklahoma presentation requirements.**

**Management is responsible for the preparation and fair presentation of the financial statements in accordance with the State of Oklahoma presentation requirements and for designing, implementing, and maintaining internal control relevant to the preparation and fair presentation of the financial statements.**

**My responsibility is to conduct the compilation in accordance with Statements on Standards for Accounting and Review Services issued by the American Institute of Certified Public Accountants. The objective of a compilation is to assist management in presenting financial information in the form of financial statements without undertaking to obtain or provide any assurance that there are no material modifications that should be made to the financial statements.**

**I compiled this financial statement from financial statements for the same period that I previously audited as indicated in my report dated March 12, 2012. My audit report was qualified because: (a) the Town has not maintained complete detailed records relating to net capital assets for both governmental activities and business-type activities, and (b) The Town has not maintained complete detailed records relating to net capital assets for the Town of Wright City Public Works Authority enterprise fund.**

**This financial statement (including related disclosures) is presented in accordance with the requirements of the State of Oklahoma, which differ from generally accepted accounting principles. Accordingly, this financial statement is not designed for those who are not informed about such differences.**
