MANAGEMENT'S DISCUSSION AND ANALYSIS

Our discussion and analysis of the Flint Ridge Rural Water District's financial performance provides an overview of the District's financial activities for the fiscal year ended December 31, 2015. Please read it in conjunction with the Auditor's reports and financial statements.

FINANCIAL HIGHLIGHTS

The District's net assets decreased by \$145,870 or 5.55% from \$2,627,344 to \$2,481,474. Operating revenues increased by \$33,829 or 7.54% from \$448,245 to \$482,074. Operating expenses increased \$45,527 or 9.12% from \$495,711 to \$544,224. The operating revenue increase was due to wholesale water sales from Delaware RWD #11 who began selling water to Colcord in July 2015. The Board approved the 2015 budget anticipating a negative cash flow for the year. Rather than increasing water rates to customers, the Board chose to use prior year miscellaneous income to fund the 2015 shortfall with the anticipation of increased water sales from Colcord. In March 2015 the Board chose to make management changes and to make a concentrated effort to reduce water loss by adding additional employees and purchasing new meters and leak detection equipment. The result was an increase in actual expenses exceeding budgeted expenses by a significant amount. In May and June of 2015 heavy rainfall occurred that washed out the main line between RV Park I and RV Park II resulting in loss of water in RV Park I. Then again in late December flood damages occurred that did major damage to raw water intake. Together these floods increased expenses in maintenance and chemicals by approximately 25%.

USING THIS ANNUAL REPORT

This annual report consists of a series of financial statements. The Statement of Net Assets shows the net assets and liabilities of the District at year-end. The Statement of Activities shows the District's income and expenses for the current year. The Statement of Cash Flows shows the cash position of the District at year-end and reflects the change in cash balances from the beginning of the year to the year-end.

REQUIRED FINANCIAL STATEMENTS

The financial statements of the District report information about the District using accounting methods similar to those used by private sector companies. These statements offer short- and long-term financial information about its activities. The Statement of Net Assets includes all of the District's assets and liabilities and provides information about the nature and amounts of investments in resources (assets) and obligations to creditors (liabilities). It also provides the basis for computing rate of return, evaluating the capital structure of the District and assessing the liquidity and financial flexibility of the District. All of the current year's revenues and expenses are accounted for in the Statement of Activities. This statement

measures the success of the District's operations over the past year and can be used to determine profitability, credit worthiness, and whether the District has successfully recovered all of its costs through its user fees and other charges. The final required financial statement is the Statement of Cash Flows. The primary purpose of this statement is to provide information about the District's cash receipts and cash payments during the reporting year. The statement reports cash receipts, cash payments, and net changes in cash resulting from operations, investing, and capital and non-capital financing activities and provides answers to such questions as "from where did cash come?," "for what was cash used?", and "what was the change in cash balances during the reporting period?"

FINANCIAL ANALYSIS OF THE DISTRICT AS A WHOLE

One of the most important questions asked about the District's finances is "Is the District, as a whole, better-off or worse-off as a result of the year's activities?". The Statement of Net Assets and Statement of Activities report information about the net assets of the District's activities in a way that will help answer this question. These two statements report the net assets of the District and changes in them. You can think of the District's net assets—the difference between assets and liabilities—as one way to measure financial health or financial position. Over time, increases or decreases in the District's net assets are one indicator of whether its financial health is improving or deteriorating. However, you will need to also consider other non-financial factors such as changes in economic conditions, population growth, and new or changed legislation that may affect the District.

Our analysis below focuses on the District's net assets (Table 1) and changes in net assets (Table 2) during the year.

CAPITAL ASSETS AND DEBT ADMINISTRATION

Capital Assets

As of December 31, 2015, the District had \$5,635,926 invested in capital assets (net of depreciation).

Debt

The District had outstanding notes payable of \$3,245,148 (including the current part) as of December 31, 2015 Additional information on the District's long-term debt can be found in Note II to the financial statements.

ECONOMIC FACTORS AND NEXT YEARS BUDGETS AND RATES

Water consumption has remained steady over the past several years. In considering the District's financial condition, the Board estimates that revenues and expenses in the coming year will increase significantly with the additional supply to Colcord via RWD #11. Wholesale water sales will double in comparison to 2014 water sales and chemicals, utilities, and maintenance costs will increase due to increased production of water. These changes are reflected in 2016 budget.

This financial report is designed to provide our customers and creditors with a general overview of the District's finances and to show the District's accountability for the money it receives. INDEPENDENT AUDITOR'S REPORT

To the Board of Directors Flint Ridge Rural Water District.

Report on the Financial Statements

We have audited the accompanying financial statements of the business-type activities of the Flint Ridge Rural Water District, Adair & Delaware Counties, as of and for the year ended December 31, 2015, and the related notes to the financial statements, which collectively comprise the District's basic financial statements as listed in the table of contents.

Management's Responsibility for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America; this includes the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Auditor's Responsibility

Our responsibility is to express opinions on these financial statements based on our audit. We conducted our audit in accordance with auditing standards generally accepted in the United States of America and the standards applicable to financial audits contained in Government Auditing Standards issued by the Comptroller General of the United States. Those standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. Other Matters

Required Supplementary Information

Accounting principles generally accepted in the United States of America require that the budgetary comparison information on page 22 and the management discussion and analysis on pages 1-3 be presented to supplement the basic financial statements. Such information, although not a part of the basic financial statements, is required by the Governmental Accounting Standards Board, who considers it to be an essential part of financial reporting for placing the basic financial statements in an appropriate operational, economic, or historical context. We have applied certain limited procedures to the required supplementary information in accordance with auditing standards generally accepted in the United States of America, which consisted of inquiries of management about the methods of preparing the information and comparing the information for consistency with management's responses to our inquiries, the basic financial statements, and other knowledge we obtained during our audit of the basic financial statements. We do not express an opinion or provide any assurance on the information because the limited procedures do not provide us with sufficient evidence to express an opinion or provide any assurance.

Flint Ridge Rural Water District Adair & Delaware Counties, Oklahoma Notes to Financial Statements For the Year Ended December 31, 2015

The following notes to the financial statements are an integral part of the Flint Ridge Rural Water District's financial statements.

I. Summary of Significant Accounting Policies

Effective October 1, 2003, Flint Ridge Rural Water District (Adair and Delaware Counties) was formerly reorganized with a new board of directors under the provisions of the laws of the State of Oklahoma. The District was previously operated as a component unit of the Flint Ridge Property Owners Association. It is exempt from federal income tax under section 115 of the Internal Revenue Code. Its purpose is to provide for the use of and benefit of its members, a water treatment and distribution system, operations and maintenance.

The membership consists of approximately 550 users, each entitled to one vote. The Board of Directors consists of 7 members serving 3-year terms. The vacant Board seats are elected at the annual meeting, and following, the Board of Directors meet and elect a chairman, Vice-chairman, Secretary, and Treasurer.

The more significant of the government's accounting policies are described below.

A. Reporting Entity

The District complies with GASB Statement No 14, "The Financial Reporting Entity." This statement establishes standards for defining and reporting on the financial reporting entity. It defines component units as legally separate organizations for which the elected officials of the primary government are financially accountable and other organizations for which the nature and significance of their relationship with a primary government are such that exclusion would cause the reporting entity's financial statements to be misleading or incomplete.

The District considered all potential component units in determining what organizations should be included in the financial statements. Based on these criteria, there are no component units to include in the District's financial statements.

B. Measurement Focus and Basis of Accounting and Basis of Presentation - Fund Accounting

The District's fund is an enterprise fund. Enterprise funds are proprietary funds used to account for business-like activities provided to the general public. These activities are financed primarily by user charges and the measurement of financial activity focuses on net income measurement similar to the private sector.

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with Generally Accepted Accounting Principles (GAAP) promulgated in the United States of America. The accounting and financial reporting treatment is accounted for on a flow of economic resources measurement focus. With this measurement focus, all assets and liabilities associated with the operation are included on the statement of net assets. The statement of activities presents increases (e.g. revenues) and decreases (e.g. expenses) in net total assets. Depreciation expense is provided for capital assets based upon estimated useful lives.

Financial activity is accounted for on the flow of economic resources measurement focus using the accrual basis of accounting. Under this method, revenues are recorded when earned and expenses are recorded at the time liabilities are incurred. In compliance with the Governmental Accounting Standards Board (GASB) Statement No. 34 "Basic Financial Statements—and Management's Discussion and Analysis—for State and Local Governments which requires the classification of net assets into three components—invested in capital assets, net of related debt, restricted; and unrestricted.

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

C. Assets, Liabilities, and Net Assets

1. Deposits and Investments

Oklahoma statutes authorize the District to invest in certificates of deposit, repurchase agreements, passbooks, bankers' acceptances, and other available bank investments provided that all deposits are fully covered by approved securities pledged to secure those funds. In addition, the District can invest in direct debt securities of the United States unless such investment is expressly prohibited by law.

All the bank deposits are held at financial institutions and are carried at cost. For purposes of statement of cash flows, the District considers cash and highly liquid investments with an initial maturity of three months or less to be cash equivalents.

Custodial Credit Risk

At December 31, 2015, the District held deposits of approximately \$121,375.27 at financial institutions. The District's cash deposits, including interest-bearing savings accounts, are entirely covered by Federal Depository Insurance (FDIC) or direct obligation of the U.S. Government insured or collateralized with securities held by the District or by its agent in the District's name.

Investment Interest Rate

The District does not have a formal investment policy that limits investment maturities as a means of managing its exposure to fair value losses arising from increasing interest rates.

Investment Credit Risk

The District has no Policy that limits its investment choices other than the limitation of state law as follows:

- a. Direct obligations of the U.S Government, its agencies and instrumentalities to which the full faith and credit of the U.S. Government is pledged, or obligations to the payment of which the full faith and credit of the State is pledged.
- b. Certificates of deposits or savings accounts that are either insured or secured with acceptable collateral with instate financial institutions, and fully insured certificates of deposit or savings accounts in out-of-state financial institutions.
- c. With certain limitation, negotiable certificates of deposit, prime banker's acceptances, prime commercial paper and repurchase agreements with certain limitations.
- d. County, municipal or school district tax supported debt obligations, bond or revenue anticipation notes, money judgments or bond or revenue anticipation notes of public trusts whose beneficiary is a county, municipality, or school district.
- e. Notes or bonds secured by mortgage or trust deed insured by the Federal Housing Administrator and debentures issued by the Federal Housing Administrator, and in obligations of the National Mortgage Association.

Concentration of Investment Credit Risk

The District places no limit on the amount it may invest in any one issuer. The District has the following credit risk: 100% in Savings Account (\$34,095.97).

2. Fair Value of Financial Instruments

The District's financial instruments include cash and cash equivalents, accounts receivable, accounts payable, and notes payable. The District's estimates of fair value of all financial instruments do not differ materially from the aggregate carrying values of its financial instruments recorded in the accompanying financial statements. The carrying amount of these financial instruments approximates fair value because of the short maturity of these instruments.

3. Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Accordingly, actual results could differ from those estimates

4. Inventory

Inventory consists primarily of distribution repair supplies and is counted annually. The District does not maintain an inventory.

5. Accounts Receivable

Accounts receivable consists primarily of charges for water sales. Management has established a provision for uncollectible accounts. Such amounts are written off the month in which management determines they are

uncollectible. Bad debts recovered are offset against bad debts expensed in the year recovered. In 2015 Bad debts recovered were \$1,363.39 and Bad debts expensed were \$3,780.25 resulting in a Bad debts expense for the year of \$2,417.36.

6. Restricted Assets

The terms of the loan agreement with the United States Department of Agriculture Rural Development (USDA) require the District to set aside in a Reserve the sum of 10% of the monthly installments or \$1,402.20 each month until there is accumulated in that account the sum of the annual installment (\$168,264.00), after which deposits may be suspended, except to replace withdrawals. In the Letter of Conditions for RD Loan #9106, funding a depreciation reserve for short-lived assets of \$476.92 monthly was required in addition to that required for debt service reserve. The monthly deposits were required when repayment began on each of the loans. The required Reserve Account balance was \$85,340 for debt reserve. The SLA reserve had an available balance of \$286.42 of which 9,932 was approved by the Board for major repairs to the River Pump leaving a SLA balance of \$0.00 at year-end. The restricted account had a balance of \$85,625.92 on December 31, 2015 which meets the reserve requirement.

C. Assets, Liabilities, and Net Assets (continued)

7. Capital Assets

The water storage and delivery system and furniture and equipment are recorded at cost. Donated capital assets are reported at estimated fair market value at the date of donation.

The cost of normal maintenance and repairs that do not add to the value of the asset or materially extend asset lives are not capitalized.

All reported assets are depreciated on the straight-line basis over their estimated useful lives ranging from five to fifty years.

All assets with a value of \$150 or more that benefit more than one period will be depreciated.

8. Equity Classifications

Equity is classified as net assets and displayed in three components:

- a. Invested in capital assets, net of related debt—Consists of capital assets including restricted capital assets, net of accumulated depreciation and reduced by the outstanding balances of any mortgages, notes, or other borrowings that are attributable to the acquisition, construction, or improvement of those assets.
- b. Restricted net assets—Consists of net assets with constraints placed on the use either by (1) external groups such as creditors, grantors, contributors, or laws or regulations of their governments; or (2) law through constitutional provisions or enabling legislation, or (3) elected restrictions by management concerning cash to be used for capital improvements.
- c. Unrestricted net assets—All other net assets that do not meet the definition of "restricted" or "invested in capital assets, net of related debt".

9. Contingencies

According to management there may be a contingent liability of \$21,866.49 at December 31, 2013 which would have a material effect on the financial statements. It is management's opinion that engineering fees of an initial study for an addition to the water supply and treatment system were to be billed only when the project for such

expansion was funded. This opinion is based on past experience for the past two projects with this engineer regarding preliminary engineering studies.

10. Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

The District has a loan with USDA Rural Development (Loan #9103 with an interest rate of 4.25% for water system improvements. The loan dated April 14, 2005 is for an original loan amount of \$298,000 and will mature in year 2045. This note has monthly payments of \$1,306.

The District has a loan with USDA Rural Development (Loan #9104), with an interest rate of 4.25% for water system improvements. The loan dated April 14, 2005 is for an original loan amount of \$610,000 and will mature in year 2045. This note has monthly payments of \$2,675.

The two notes payable above are secured by substantially all fixed assets, accounts receivable and assignment of revenues.

On September 17, 2009 the District entered into an agreement with USDA Rural Development to borrow \$2,608,000 for the purpose of constructing new water lines. The 40-year loan was dated September 7, 2011 at the rate of 3.375 percent per annum and included a provision that principal would begin on October 7, 2012. The note has monthly payments of \$10,041. Included in the agreement was a second agreement that the District will also receive grant funds in the amount of \$1,252,000 for the same purpose. Substantially all fixed assets, accounts receivable and assignment of revenues were pledged as security for the note. A debt service account as part of the loan agreement will be utilized to accumulate funds in sufficient amounts to pay the next installment due on the note. From the remaining funds in the general account, there shall be set aside into an account designated as the Reserve Account the sum of ten percent of the monthly installment each month until the sum of the annual installments is reached. With the prior written approval of the Government, funds may be withdrawn and used for such things as loan installments, emergency maintenance, extensions to facilities and replacement of short-lived assets, subject to conditions established by the Government. The project was delayed until year 2011 when construction began.

SCHEDULE OF FINDINGS AND QUESTIONED COSTS

<u>Criteria:</u> The segregation of duties and responsibilities between different individuals for custody of assets, recordkeeping for those assets, and reconciliation of those asset accounts is an important control activity needed to adequately protect the entity's assets and ensure accurate financial reporting.

<u>Condition:</u> Presently the same individual that is responsible for billing and adjustments; posts payment to subsidiary accounts receivable ledgers and reconciles the monthly bank statements. In addition, only limited oversight is provided over this individual in the conduct of their daily functions. This condition was also reported in 2014.

<u>Cause:</u> The entity's limited size and staffing resources have made it difficult for management to provide sufficient staffing to fully segregate incompatible duties in a cost-effective manner.

<u>Effect or Potential Effect:</u> Without sufficient segregation of duties, the risk significantly increases that errors and fraud related to the membership and other bluing and collection activities, including misappropriation of assets, could occur and not be detected within a timely basis.

Recommendation: Management and the board should consider a formal evaluation of their risks associated with this lack of duties segregation over assets. In response to the Identified risks, consideration should be given to identifying and implementing compensating duties to act as controls that could help mitigate the risks associated with lack of segregation of duties, such as management performing review procedures for the reconciliation of accounts.

<u>Responsible Official's Response:</u> The organization concurs with the recommendation, and will strive to implement procedures and compensating duties to help mitigate the risks associated with the lack of segregation of duties.
